## SBP-held foreign reserves rise above \$4b mark

KARACHI (Agencies): The State Bank of Pakistan (SBP)-held foreign exchange reserves rose above the \$4 billion mark after the cash-strapped nation received a \$500 million loan from a Chinese bank. The central bank, in its weekly bulletin, said that its foreign exchange reserves have increased by \$487 million to \$4,301 million as of the week ended March 3, which will provide an import cover of around a month.

The SBP received \$500 million last week from the Industrial and Commercial Bank of China (ICBC) as part of the institution's \$1.3 billion facility, just days after it had received \$700 million from the China Development Bank. Pakistan hasn't received funds from any friendly country except for China as the \$350 billion economy struggles to revive the

stalled International Monetary Fund (IMF) programme. Cash-strapped Pakistan has been trying to secure the IMF bailout to avert a debt default, unlock more funding and stave off severe supply shortages. There are \$7 billion of repayments in the coming months, including a Chinese loan of \$2 billion due in March, according to Fitch Ratings.

The nation needs to repay about \$3 billion dues in the upcoming payments while \$4 billion is expected to be rolled over, SBP Governor Jameel Ahmad said in an analyst briefing after the announcement of the monetary policy rate — which has been jacked by to a 27-year high of 20%. But as the IMF deal sees a deal, the Pakistan rupee has plunged to historic lows and closed at 282.30 against the dollar in the interbank market — and if

all goes well for Pakistan in the coming days, experts believe that the local currency can only recover to 265. In his address to an event earlier on Thursday, Finance Minister Ishaq Dar said that the IMF was "satisfied" with Pakistan's actions, but the staff-level agreement could not be signed this week.

"We seem to be very close to signing the staff-level agreement hopefully in the next few days," Dar said in his address during a seminar titled "Reviving Economic Stability through the Strengthening of Public Financial Management" in the federal capital. Due to a shortage of dollars, the government has also imposed restrictions on imports — resulting in the partial closure of not only textile but automobile manufacturers as well, prompting unemployment fears.

## PM okays release of wheat to GB

ISLAMABAD (PPT): Prime Minister Muhammad Shahbaz Sharif on Thursday approved immediate release of 26,666 metric tonnes of wheat to Gilgit-Baltistan (GB) for two months.

According to a notification issued by the Prime Minister office, the Prime Minister also directed the Finance Division to allocate 2.5 billion rupees for Gilgit Baltistan to meet urgent requirement of the region. The Prime Minister further directed Ministry of Kashmir Affairs to submit a comprehensive and sustainable plan for price rationalization in consultation with all stakeholders for consideration of Economic Coordination Committee within three days.

## Power tariff for Karachi to be raised

ISLAMABAD (INP): The Ministry of Energy (Power Division) decided to jack up the power tariff by Rs 4.76 per unit for K-Electric consumers in the context of two different quarterly adjustments.

The electricity tariff is likely to get expensive for the consumers of Karachi in the context of two different quarterly adjustments. The stakeholders were likely to approve the latest tariff rate from the federal cabinet meeting chaired by Prime Minister Shehbaz Sharif.

"In the first quarter adjustment of the financial year, electricity tariff will increase by Rs 3.21 per unit, while in the second quarter adjustment from last year, power tariff will increase by Rs 1.55 per unit," sources added. This tariff hike was decided to maintain a uniform tariff across the country, the additional charges will be applicable in 2023 between March and May. It is pertinent to mention here that Prime Minister Shehbaz Sharif summoned a meeting of the federal cabinet on Thursday [today] at 4 pm.

According to sources, the federal cabinet meeting will be chaired by PM Shehbaz Shaif in which Hajj Policy 2023 will be presented for approval.

## Federal Cabinet approves Hajj Policy, Clean Air policies

ISLAMABAD: The Federal Cabinet on Thursday approved the Hajj Policy 2023 and the National Clean Air Policy. Prime Minister Shehbaz Sharif, chairing the cabinet meeting, said the authorities should prepare a comprehensive and effective strategy as soon as possible in cooperation with the officials of Saudi Arabia to provide the best possible travel and lodging facilities to pilgrims during the Hajj.

He appreciated the Ministry of Climate Change for formulating the Clean Air Policy, and directed that necessary steps should be taken for its effective implementation. The Ministry of Climate Change presented the new policy before the cabinet for approval.

The cabinet was told that in the previous years air pollution had risen to dangerous levels in many big cities. According to the Air Quality Index Report 2022-23, Karachi and Lahore were the cities most affected by air pollution. It mentioned that due to air pollution the average life of people was reduced by 2.7 years. As per the 2016 report of the World Bank, Pakistan's economy was suffering huge losses because of the air pollution problem.

In recent years, the number of accidents caused by smog in cities

and different diseases spiraled. The Ministry of Climate Change prepared an extensive policy covering a number of subjects, including protection of health of citizens, steps to reduce per year deaths, promotion of agriculture, reduction in air pollution and for improvement in quality of air in urban and rural areas.

The policy recommended to encourage and promote upgradation of fuel from Euro 5 standard to Euro 6, introduce strict laws to control industrial emissions, modernize agriculture, effectively stop burning of crop waste, adopt international standards for waste management and use low emission gases in cooking. The adoption of policy would decrease emission of poisonous gases by 40 percent in the next 10 years.

The effective enactment of policy would be ensured by a National Action Committee, which would provide long term guidance for its implementation and also bring changes in it after every five years keeping in view the ground realities. A technical committee would also be constituted to come up with a strategy to ensure execution of the policy and send periodical reports to the National Action Committee.

The committee would also present recommendations to remove obstacles in the way of implementation of the policy. Execution of the clean air

policy could lead to increase in the average human life in Pakistan by two years. The cabinet was also briefed on a strategy for fuel conservation. It was told that the ministries of Power, Petroleum, Industry and Commerce and Information were ensuring on priority basis implementation of the targets set by the cabinet. On the recommendation of the Ministry of Law and Justice, the National Accountability Amendment Ordinance 2023 was approved.

The recent amendments in the National Accountability Ordinance 1999 had created legal complications because of which it became difficult to transfer a lot of cases which did not come in the ambit of NAB ordinance, to other courts, tribunals and forums. After consultation with all stakeholders, the NAB Ordinance XVIII was amended after which the accountability courts would get a legal cover to transfer cases to other courts and forums. The amendments would also end the perception that those cases which did not come in the purview of NAB Ordinance, were decriminalized. The cabinet also ratified the decisions made by the Economic Coordination Committee during its meetings held on March 1 and March 6. It also ratified the decisions taken by the Cabinet Committee for Legislative Cases in its meeting held on March 6.

## PTI serves legal notice to KP Governor

PESHAWAR: Pakistan Tehreek-e-Insaf (PTI) lawyer Qazi Muhammad Anwar Advocate served legal notice to Governor Khyber Pakhtunkhwa to announce schedule for provincial assembly elections within 24 hours otherwise to face legal proceedings, on Thursday.

In this regard, Qazi Muhammad Anwar Advocate has served urgent notice and stated that Governor has taken oath as well as dissolved Khyber Pakhtunkhwa Assembly on Chief Minister Mahmood Khan, it is obligatory for him to announce election schedule within 24 hours.

The legal notice added

that Governor didn't announced election scheduled by playing delaying tactics while he also claimed in a press conference that announcement of poll-date is responsibility of Election Commission of Pakistan. Governor has used different tactics to manipulate election schedule and also claimed that Peshawar High Court cannot directs him for announcement of election date, the legal notice argued.

Following Sou Moto notice decision by Supreme Court of Pakistan, 30th April selected for polling in Punjab by President but Governor Khyber Pakhtunkhwa once again played with ECP to manip-

ulate the announcement election date which is unconstitutional, the notice added.

The legal notice argued Governor Khyber Pakhtunkhwa to announce date within 24 hours otherwise a complaint should be filed before federation as well as legal proceeding under treason from constitution and other related affairs should be initiated against him. It is worthy to mention that Governor Khyber Pakhtunkhwa claimed that announcement of election date is more difficult than sighting Eid crescent on Wednesday while talking to media personnel following his meeting with Election Commission of Pakistan.

## LHC suspends ban on airing of Imran's speeches

LAHORE (Agencies): The Lahore High Court (LHC) on Thursday suspended the ban imposed by the Pakistan Electronic Media Regulatory Authority (PEMRA) on broadcasting live or recorded speeches of Pakistan Tehreek-e-Insaf (PTI) chief Imran Khan on satellite TV channels.

Justice Shams Mehmood Mirza presided over the petition filed by the former premier challenging PEMRA's ban and announced the reserved verdict. He also proposed the formation of a full bench to hear the case. The prohibition order stated that Imran was "levelling baseless allegations and spreading hate speech through his provocative statements against state institutions and officers which is prejudicial to the maintenance of law and order and is likely to disturb public peace and tranquillity".

PEMRA had said the airing of hateful, slanderous and unwarranted statements against state institutions is "in sheer violation of Article 19 of the Constitution and a judgment of the Supreme Court". It has been observed that such content was telecasted by TV channels without effective utilisation of time-delay mechanism in violation of provisions of PEMRA laws as well as judgments of the apex courts, the media regulator added.

Challenging the order, Imran had filed a petition with the LHC through barrister Muhammad Ahmed Pansota, contending that in the judgment reported as "Imran Ahmad Khan Niazi Vs PEMRA", then chief justice of the Islamabad High Court (IHC) Athar Minallah had declared a similar PEMRA prohibition order as "ultra vires the Ordinance" (over-stretching itself beyond the powers conferred upon it) on similar grounds. Imran's counsel had stated in the petition that PEMRA has issued the impugned order in excess of the jurisdiction vested in it and without having regard to the constitutional rights guaranteed under Articles 19 and 19-A of the Constitution.

Justice Shahid Bilal Hassan had on Wednesday recused himself from hearing the case and sent the case file to the LHC chief justice, requesting to fix it to another bench. As proceedings commenced, Imran's counsel argued that PEMRA on March 5, 2023, issued an impugned order, arguing that the regulatory body's allegations were untrue.

## Imran, PTI leaders booked over chaos in Lahore protest

LAHORE (INP): Punjab police on Thursday lodged a case against Pakistan Tehreek-e-Insaf (PTI) chairman Imran Khan and other PTI leaders over creating chaos during PTI's protest in Punjab's capital.

A First Information Report (FIR) lodged against Mr Khan stated that up to 400 people including armed men vandalised the venue and threatened the security institutions on the guidelines of Mr Khan and PTI leaders including Farrukh Habib, Fawad Chaudhry, Hammad Azhar, Mahmoodur Rasheed, Ijaz Chaudhry, and others. "Enraged protestors pelted stones at the police personnel", the report added.

The FIR stated that PTI activists' vandalism injured 13 police officials as well as six activists. "They were shifted to Services hospital where injured Ali Bilal succumbed to his injuries", the report added. Taking to Twitter, PTI senior vice president Fawad Chaudhry wrote, "I have been in Islamabad for past two days to plead the court for Mr Khan's security, but Punjab police lodged a case against me over vandalism in Lahore. It reflects the credibility of administration that has been imposed in Punjab". Earlier, the party had planned to kick start its election campaign with a rally from Zaman Park to

Data Darbar. However, it later put off the campaign until Saturday but dedicated the rally to the judiciary.

Before the start of the rally, the Punjab government imposed Section 144 in Lahore for seven days with immediate effect, banning rallies, processions and gatherings in the provincial capital due to security reasons. Later, the PTI called off its pro-judiciary rally. Soon after the imposition of Section 144, police started detaining PTI workers and closed roads leading to Zaman park to block the rally. Things turned sour when police officials resorted to tear gas shelling, water canons and baton charge to disperse the participants from gathering for the rally. It left multiple injured and one dead, and Mr Khan claimed that he had been murdered by the police.

Terming it a black day, the PTI stated, "Another dark chapter of tyranny and repression and the worst fascism has been added in the history of those committing the crime of upholding democracy through law." A spokesperson of the Punjab government rejected the claims of custodial killing, saying the purported videos were not from Wednesday's incident but the 'Jail Bhao Tehreek' (court arrest movement). Amnesty

International expressed concern over the "blanket ban" on protests in the province's capital. Taking to Twitter, it wrote, "Authorities in Pakistan has placed a blanket ban on protests in Lahore. The authorities have used a draconian colonial-era law to crush dissent hours before several protests".

**Govt forms committee to probe Lahore clashes between police, PTI workers:** The Punjab government has formed an inquiry committee to ascertain facts into the incidents of police clashes with workers of the Pakistan Tehreek-e-Insaf (PTI) in Lahore. PTI Chairman Imran Khan said on Wednesday that one of its workers was killed after police launched a crackdown on those participating in the party's rally following the imposition of Section 144.

In January, the politician told the foreign media that he is not greedy for power and he wanted to leave a legacy after joining PTI. He added that a democratic political party must exist in the country.

To a question, he said that he will always share his thoughts before whatever political party he joins. He added that he will definitely consider joining a political party if its manifesto is in line with his thoughts.

# Federal Cabinet approves much needed National Clean Air Policy: Sherry

ISLAMABAD (APP): Federal Minister for Climate Change Senator Sherry Rehman on Thursday said the Federal Cabinet had approved the much needed 'National Clean Air Policy', proposed by the Ministry of Climate Change.

The minister, in a series of tweets, thanked all the cabinet members for unanimously approving the policy.

Sherry Rehman said: "This policy was the need of the hour which has been formulated in consultation and partnership with all

stakeholders. It aims to

reduce air pollution in Pakistan, improve air quality, reduce annual deaths, improve citizens' health, increase economic activity and ensure food security."

She said Pakistan was the third most polluted country in the world in terms of air pollution in 2021, while Lahore and Karachi were the most polluted cities in Air Quality Index 2022-23.

"Air pollution has become a serious environmental and health problem. In 2019, 235,000 people died due to air pol-

lution in Pakistan."

The minister noted that air pollution had shortened the average life expectancy in Pakistan by 2.7 years.

According to the World Bank, she said, air pollution in 2013 caused an economic loss of \$47.8 billion in Pakistan, which was 5.88% of the GDP (gross domestic product).

"We needed a comprehensive policy to reduce these losses. All losses can be mitigated by the technical and administrative measures of this policy," Sherry Rehman said.

# AIOU has become first priority for women living in remote areas: VC

KARACHI (PPI) Vice Chancellor Allama Iqbal Open University (AIOU) Prof. Dr. Nasir Mahmood said that AIOU has become the first priority for women living in remote areas of the country, especially girls who have given up on education due to social and economic constraints.

Sharing his views during a discussion with journalists, the VC AIOU further informed that out of 1.2 million registered students at this national university, more than 51% are female students. Dr. Nasir said that AIOU is playing an exemplary role in increasing the literacy rate of the country, for this purpose, the university provides free matriculation education in

Balochistan, Gilgit-Baltistan and merged districts (Ex-FATA). He said that the university also provides free education to disabled persons, transgenders, and jail inmates, as education is the basic right of everyone.

AIOU also provides scholarships and fee concessions to poor and deserving students across the country who cannot continue their education due to financial constraints, he added. Dr. Nasir Mahmood further said that the entire system of AIOU has been digitized.

Books of matriculation, FA, and BA are being dispatched as per the previous procedure, while the books of all other programs are available on our website (www.aiou.edu.pk). Dr.

Nasir Mahmood, in response to a question, said that students of areas where internet facilities are not available can avail the free internet facility at the nearest regional offices of the university to upload assignments, attend workshops, and online classes.

Answering another question, Dr. Nasir Mahmood said that to maintain the quality of teaching and learning, teachers from all the universities across the country are registered with us as part-time tutors.

He said there is a monitoring system in the quality enhancement cell and not a single fake degree of AIOU has been reported to date, which indicates the efficiency of monitoring system of this university.

## Govt does not seem in election mood: Rashid

LAHORE (NNI): Awami Muslim League (AML) chief Sheikh Rashid Ahmad said it seemed that the government was not in the mood of holding elections.

In a series of tweets, the former interior minister welcomed the announcement of schedule for polls in Punjab by the Election Commission of Pakistan (ECP) and hoped that they would not be delayed further.

He said the government could face contempt of court proceedings by delaying the elections as the Supreme Court had ruled polls must be held within 90 days of the dissolution of the assemblies.

He also hit out at Khyber Pakhtunkhwa Governor Ghulam Ali for not implementing the court orders, adding that the delaying tactics were being used under a conspiracy. He claimed that political decisions would now be taken in courts in coming days.

The government was only running after its vested interests instead of bringing political and economic stability in the country. He also lashed out at the interim government, saying it was only responsible for holding elections but it imposed Section 144 the day election schedule was announced. He said one worker of the PTI was died during Lahore rally, adding that attempt to suppress the PTI proved damaging for the government.

# JI Emir demands general elections, linking stability to national poll

the port city had given mandate to the JI which would give mayor to them.

He said the PDM and the PPP government failed to control inflation and ensure peace and order. He said 11 months of the current government were the reflection of the poor performance of 14 parties.

He said the unity government continued the policies of the PTI, gifting the people with inflation and unemployment. He said since the ruling parties failed to perform, the JI was left as the only option with the people to vote for in elections. If voted to power, he said, the JI would transform the country into Islamic welfare state.

PESHAWAR: A divisional bench comprising of Chief Justice Peshawar High Court (PHC) Justice Qaiser Rashid and Justice Ijaz Anwar annoyed absence of Secretary and Director Elementary & Secondary Education from court in cases regarding unavailability at Government Schools, on Thursday.

During hearing Additional Advocate General Syed Sikandar Shah and District Education Officer (DEO) Male Liaquat Ali appeared before PHC in writ filed by Subhan Ullah stating that Government Model School lacking furniture while students are

compelled to learn in deteriorating building.

DEO Male informed that he visited the said schools which lack furniture with deteriorating building while added that an alternative space should be provided soon to the school.

In the meantime, Chief Justice Qaiser Rashid observed that unfortunately students are compelled to obtain education within worsening building which lacks both furniture and electricity while inquired regarding responsibility in case of collapsing the structure?

Director and Secretary Education didn't leaving their offices to see what is going on in the department

and does not come to court for submitting report that everything is right, the chief justice remarked.

DEO Male Mohmand informed that Rs1 million is available with the department and two rooms should be constructed on available resources while DEO Female Khyber informed that she personally visited Government Middle School which lacks furniture but bid has been announced in this regard. However, Deputy Director Education informed that availability of facilities was delayed due to lack of funds.

Although, Chief Justice annoyed unavailability of funds and remarked that money is available for

everything expect education while ordered Secretary Finance to release funds within 15 days for provision of furniture.

On resuming of hearing Secretaries Education and Finance Mustasim B Allah and Muhammad Ayaz respectively while assured that furniture should be provided within 24 hours to the said school and added that bids had already announced for other schools across erstwhile Fata.

Secretary Finance Muhammad Ayaz that department will release funds immediately following requisition from education's department while divisional bench of PHC adjourned further hearing.

Meanwhile, speaking on the occasion, Prof. Dr. Zia ul Haq said that today was a very happy day for us because today we had successfully tested e-assessment which would not only ensure transparency in exams but would also save time and resources besides

ensuring the release of results within 48 hours.

He said that we have set a target to convert all MBBS, BDS, nursing and allied health sciences traditional method exams to modern e-assessment systems within the next six months.

The VC said that this system had already been approved by the academic council of the University, therefore we had decided to convert all paper-based undergraduate and post-graduate examinations into e-assessment of computer-based examinations for which development of the software and hardware was in progress on a daily basis and the day was not far when all KMU exams will be transferred from paper to computer in the near future.

## YDA deplores Rs444m alleged misappropriation of funds under SIC

PESHAWAR (APP): The Young Doctors Association (YDA) Khyber Pakhtunkhwa has deplored the alleged misappropriation of Rs 444 million funds of Sehat Insaf Card (SIC) in the previous PTI tenure.

They further demanded initiation of construction of work on Darosh, Arundu, Sheshikoh roads and widening of Booni, Ower, Milkho, Trich road and construction of road leading to Chitral University besides paving of and these roads for a safe travel.

The resolution deplored inordinate delay in construction of Booni to Buzund, Torkho road, adding that the work on 32 km long road was in progress from last 14-year until now 50 per cent work could not be completed. They urged the Federal government to pursue approval of PC-1 of Chitral to Garm Chasma and Durra Pass road from ECNEC.

## Women deal with added burdens of Turkey’s quake disaster

ISTANBUL (AFP): The shelves of the makeshift clinic -- little more than an orange storage container -- offer everything women are too shy to ask for on the streets of Turkey's quake zone. From underwear to period and contraception products, doctor Meltem Gunbegi reconnects women with the basics they feel uncomfortable discussing in the crowds of mass aid distribution centres.

She also offers a receptive ear, helping the women of southern Turkey's destroyed city of Antakya to start processing the grief and death they have been subjected to in the past month. The toll from the 7.8-magnitude earthquake now stands at more than 46,000 in Turkey and at nearly 6,000 in Syria, making it one of the world's 10 deadliest of the past 100 years.

A top United Nations official said that the damage alone amounted to more than \$100 billion, with extra money needed for recovery costs. "Many are shy when it comes to asking for basics, such as bras, wax bands and tweezers, so they come and visit our container," said the 33-year-old doctor. More women are having genital issues because of poor hygiene conditions in the tent cities set up across the 11 quake-hit provinces, Gunbegi said.

But she also sees women who are clearly still in shock and too traumatised to start thinking about their own bodies -- even when they are pregnant. "They experienced a lot of death, a lot of destruction," said the doctor. "They really don't seem to think about the baby. They are in a state of trauma." Semire Duman, 51, an earthquake survivor who has been living in a tent for a month, said women have a lot of needs.

"We have no shower, no toilet, no water, nothing," she told AFP, and then almost whispering: "We don't have underwear." Gazele Sumer, 57, complained of lack of privacy in tents. "We are six people in one tent," she said. "We sit here, we eat



there, we sleep here," she added. Selver Buyukkeles, an earthquake survivor who works with the Mor (Purple) Solidarity, said women bore the brunt of daily burdens -- such as doing chores and taking care of family -- even before the February 6 quake. Now, they are trying to do the same while dealing with personal pain and an acute sense of insecurity that comes with life out on the streets.

"Women queue to get food at distribution centres. They cook, they take care of the children and the elderly. They do the dishes. They do the laundry," the 28-year-old said. "Women feel responsible for their family's situation. They fear a new earthquake and the communal life in tents makes them insecure," she said. At this stage, activists and doctors interviewed by AFP have not observed more cases of domestic violence or abuse, despite Turkey's poor record on the issue. Fidan Ataselim, secretary general of the We Will Stop Femicide Platform, has called for "safe shelters" and "prevention centres" to be set up for women in damaged regions.

We Will Stop Femicide publicises the murder and abuse of women in

the mostly Muslim but officially secular state. In 2022, at least 327 women were killed and 793 injured, according to data compiled by the platform. Back at Antakya's Dostluk (Friendship) park, not far from Gunbegi's makeshift clinic, volunteers work in shifts making sure that some 200 women sheltering in dozens of tents are safe. Others are keeping vigil outside toilets and shower cabins. "Safe zone for women and LGBT+ here," proclaim posters in Turkish and Arabic.

The Arabic is a nod to the millions of refugees and migrants who have been living across stretches of southern Turkey since the start of the civil war in neighbouring Syria 12 years ago. "We have a security system for both women and LGBT+, who are more vulnerable in such disasters," said Aslihan Keles, 23, one of the volunteers in the park. Turkish women often join marches on March 8 -- the official International Women's Day -- demanding better lives and protection against domestic violence. But this year, things are different in the quake zone, Keles said. "Here, there is an emergency," she said. "This time, we are in field -- but for a very good cause."

## Two dead in Chile airport attempt

SANTIAGO (Agencies): An attempted multimillion-dollar airport heist in Chile has resulted in a shootout that left a would-be robber and an airport security official dead. The botched endeavour took place at the Arturo Merino Benitez International Airport in the capital of Santiago. Between 10 and 12 robbers attacked as airport workers were moving \$32.5m in cash off of a plane.

"Valuable cargo arrived on a LATAM plane from Miami which was to be taken by the Brinks [security] company, at which point the subjects burst into the area and were repelled by security officials," said Eduardo Baeza, a prosecutor tasked with leading the investigation. Organised crime has been a concern in Chile in recent years, and the airport has been targeted in the past. In 2017, an armed group stole about \$18m, and three years later a similar heist took \$15m from an armoured truck.

Deputy Interior Minister Manuel Monsalve told reporters that security officials entered into a shootout with the robbers, foiling a "highly organised, highly armed and probably very well-planned robbery". Authorities said that one of the assailants and an airport security official were killed. Monsalve told reporters that the robbers tied up a security guard and entered the airport in three vehicles. The AFP news agency reported that the robbers broke through a gate and headed to the cargo area, where they hoped to intercept the \$32.5m before it was moved locally. After being confronted by security officials, the armed men reportedly fled, setting two of their vehicles on fire on a nearby highway. A search for the perpetrators is ongoing.

## Seven dead in Syria drone strike

DAMASCUS (AFP): Seven people including several civilians were killed when a drone strike targeted a weapons factory belonging to Iran-backed factions in government-held eastern Syria, a war monitor said. It was not immediately clear who was behind the strike in Deir Ezzor province, where Iran-backed factions hold sway and where a US-led coalition and Israel have previously carried out attacks.

"Seven people were killed and 15 wounded in a drone strike targeting a weapons factory and a truck loaded with weapons," both belonging to Iran-backed groups, said Rami Abdel Rahman, who heads the Britain-based Syrian Observatory for Human Rights. Three pro-Iranian fighters from Afghanistan, three Syrian civilians and one unidentified Syrian were killed, Abdel Rahman told AFP, adding that the building targeted was only recently converted into an arms factory.

Israel has carried out repeated air and missile strikes against government forces and their Iran-backed allies in Syria since the civil war broke out in 2011. It rarely comments on individual military operations. A US-led coalition fighting the remnants of the Islamic State jihadist group in Iraq and Syria has also carried out strikes against pro-Iran fighters in Syria in the past. Attack targeted a part of Deir Ezzor that is home to residences of top Iranian commanders and senior officers of Lebanon's Hezbollah movement as well as an Iranian hospital for cholera patients, Abdel Rahman said.

Pro-Iran factions aligned with the Syrian government, including Iraqi groups and Hezbollah, are heavily deployed south and west of the Euphrates River which bisects Deir Ezzor province. Syrian state media said a landmine planted by Islamic State group "terrorists" exploded in the same neighbourhood, killing three and wounding seven. "Three citizens were killed and seven others injured" in the explosion, state news agency SANA reported. It published photographs of the aftermath of the blast that showed extensive damage to a building and a truck.

## Syria child quake victims, flown to UAE, unaware of heartbreak to come

DUBAI (AFP): Cradling a pink stuffed animal as she sleeps in a United Arab Emirates hospital, a nine-year-old Syrian earthquake survivor is recovering from the wounds that nearly claimed her life, believing her mother is still alive.

Sham Sheikh Mohammad, who suffered severe crush injuries in a 40-hour ordeal under the rubble, has not yet been told that both her mother and sister died in the February 6 earthquake that killed more than 50,000 people in Syria and Turkey. "I tell her that her mother is in critical care and that her condition is difficult," said her father, Mohammad, who has barely slept since Sham and his 15-year-old son, Omar, were taken from Syria's rebel-held northwest to Turkey and then flown to Abu Dhabi for emergency medical treatment.

Sham's story captivated Syrians and others around the world after a viral video showed her humming a tune with the White Helmets rescue group that worked for six hours to free her. She and her brother are among 12 Syrian quake survivors who were flown by the UAE for specialist care for their crush injuries in Abu Dhabi.

Doctors at the Burjeel Medical City hospital say they have "controlled" life-threatening infections in her lower limbs, without commenting on whether they were forced to amputate. "Sham's condition is stable," said her father, also declining to give further details. Sham's survival encapsulated the tragedy, hope and heartbreak of the 7.8-magnitude quake that levelled buildings across Turkey and parts of Syria last month.

After her rescue in the town of Armanaz, in Idlib province, captured global attention, the UAE dispatched a medical aircraft to fly her and Omar to Abu Dhabi from Istanbul. "Both children are now recovering well," their doctor in Abu Dhabi, Michael Uglov, said in a statement last week. But Sham is not the only young survivor who will soon face a harrowing revelation. In a nearby hospital, Israa al-Abdullah receives routine updates on her medical condition but no news on the fate of her family.

Like Sham, the 17-year-old from the

Syrian government stronghold of Jableh was rescued after spending hours trapped in rubble. She has injuries to her skull, pelvis and shoulder and nerve damage in her eyes, said her brother Mohammad, a Syrian army soldier who was in Damascus when the quake hit. What Israa doesn't know is that her parents and four other siblings all died in the earthquake, along with a brother's wife and daughter. Israa, her 12-year-old sister and one nephew were the only survivors.

"We told her that everyone is alive," said Mohammad, closing the door of Israa's hospital room so she couldn't overhear. Israa asks most about her mother, her sister Ghufra as well as her young niece Jana -- all of whom were killed, Mohammad said. "I tell her I don't have phone credit in the UAE" when she asks to speak to them, he told AFP at the Sheikh Shakhbout Medical City hospital. Hooked to monitors and an intravenous drip, Israa pants heavily but can barely speak. The nerve damage has left her cross-eyed and suffering from impaired vision.

Doctors say she will likely make a full recovery, according to Mohammad. But until she improves, the truth about her family will remain a secret. "I buried my family members one after the other," Mohammad said. "I can't tell (Israa) anything until God cures her and she can get up on her own two feet." In a nearby room, Ali Yusef Remmo, a displaced Syrian from the countryside of Latakia province, is receiving treatment for injuries in his lower limbs. The father of three has regained partial leg mobility and is confident that he will walk again. But he is plagued by the loss of his youngest son and his wife, who was two months pregnant when their building collapsed.

The hardest part of being in an Emirati hospital, he said, is receiving platefuls of food, knowing he couldn't afford dinner for his family the day the tremor took their lives. "My son died hungry," he said, tears swelling in his eyes. "When I come to eat chicken, or meat, or an apple or a biscuit, I think that my 10-year-old was deprived of all of these things."

## NATO cautious amid ongoing blasts probe

BRUSSELS (Agencies): NATO Secretary-General Jens Stoltenberg has called for caution following media reports that a pro-Ukrainian group may be responsible for blowing up the Nord Stream pipelines supplying Russian energy to Europe. While not pointing to any official Ukrainian involvement, a New York Times report published said intelligence reviewed by United States officials found a pro-Kyiv group may be behind the attacks in September, which became a flashpoint between the West and Russia after last year's Russian invasion of Ukraine.

"There are ongoing national investigations and I think it's right to wait until those are finalised before we say anything more about who was behind it," Stoltenberg said. The explosions on the pipelines connecting Russia and Germany took place on September 26 in the exclusive economic zones of Sweden and Denmark. Both countries have concluded the blasts were deliberate but have not said who might be responsible.

Russia, which has previ-

ously blamed the West, seized on the news to demand a transparent investigation in which it also wants to participate. Kremlin spokesman Dmitry Peskov suggested the media reports were a coordinated bid to divert attention and questioned how US officials could assume anything about the attacks without an investigation. Ukrainian Defence Minister Oleksii Reznikov said the media reports were a "little bit strange" and had "nothing to do" with the Ukrainian government.

Reznikov said he was not worried about the prospect of the media reports weakening support for Ukraine. Germany warned against "jumping to conclusions". "We have to make a clear distinction whether it was a Ukrainian group, whether it may have happened at Ukrainian orders, or a pro-Ukrainian group [acting] without knowledge of the government," German Defence Minister Boris Pistorius said. Pistorius said on the sidelines of a summit in Stockholm that the likelihood was "equally high" that it could have been a

"false flag operation staged to blame Ukraine".

Meanwhile, Germany's federal prosecutor confirmed that investigators had raided a ship in January that may have been used to transport the explosives used to blow up the pipelines, but said there was no reliable information yet on motives, perpetrators, or whether the attack was state-sponsored. European Union foreign policy chief Josep Borrell told reporters that there was "no suspicion against employees of the German company that rented out the ship". "As long as investigations into Nord Stream blasts are ongoing, we can not draw conclusions," Borrell said.

Germany's ARD broadcaster and Zeit newspaper said that the operation to place explosives on the seabed was carried out by six people, five men and one woman, who used forged passports. They transported explosives on a yacht rented from a German charter company by a Poland-based firm owned by Ukrainian citizens, according to the report and prosecutors.

## No to the Russian law: Georgians protest bill

TBLISI (Agencies): Police in the Georgian capital Tbilisi have fired water cannons and tear gas to disperse crowds protesting against a proposed "foreign agents" law that is reminiscent of a Russian measure used to silence critics. Hundreds of police converged on streets around Georgia's parliament building in a bid to break up the protests. Thousands gathered there for a second day, holding Georgian and European Union flags and chanting "no to the Russian law".

Tear gas billowed down Tbilisi's central Rustaveli Avenue, where parliament is located, forcing at least some of the demonstrators to move away. The protesters are demanding authorities drop the bill on "transparency of foreign funding", which requires any organisations receiving more than 20 percent of their funding from overseas to register as "foreign agents" or face substantial fines. The ruling Georgian Dream party says it is modelled on legislation in the United States that dates from the 1930s. Critics, including President Salome Zourabichvili, say it is similar to a law Russia enacted in

2012 that has been used to shut down or discredit organisations critical of the government and could harm Georgia's chances of EU membership.

Georgia applied for EU membership together with Ukraine and Moldova days after Russia invaded Ukraine in February last year. In June, EU leaders granted formal candidate status to Kyiv and Chisinau but told Tbilisi it had to implement several reforms before it could be considered. Thousands of people have been massing for days in Tbilisi to protest against the law and clashes broke out after legislators approved the measure in its first reading. Police used tear gas and water cannon against the demonstrators and said more than 70 people had been detained. Some 50 police officers were also wounded, they said. The protests restarted with a march down Rustaveli Avenue to mark International Women's Day, which is a public holiday.

"We cannot let our country become pro-Russian or a Russian state, or undemocratic," said Vakhtang Berikashvili, a 33-year-old software engineer. Another

protester, Elene Ksovreli, 16, said the Georgian people "will not allow them to make Russia define our future". "We, young people, are here to protect our everything," she told the AFP news agency. Aza Akhvediani, 72, called the Georgian government "stupid". "I know what's happening in Moscow. They stop every passerby and do whatever they please to them. I think the Georgian government wants the same," she said. Politicians in the EU have also expressed concern.

The draft law "goes directly against the Georgian authorities' declared ambition to receive candidate status for EU membership", said a statement from EU members Maria Kaljurand and Sven Mikser. "The new law's purpose, under the guise of promoting transparency, is to stigmatize the work of civil society organizations and media," the statement added. In response to the situation, the US urged the Georgian government to show "restraint" and allow peaceful protests, while Ukrainian President Volodymyr Zelenskyy called for "democratic success" in "friendly Georgia".

## Nigeria postpones local state election after court ruling

NAIROBI (AFP): Nigeria's electoral agency said it had postponed a weekend governorship election by one week following a court decision over machines used in voting tallies.

The so-called BVAS machines are at the centre of a legal dispute over last month's contested presidential election which results show Nigeria's ruling APC party candidate won, but the opposition claims was marred by massive tampering. With President Muhammadu Buhari stepping down in May after two terms, many Nigerians hoped a clean, transparent vote would usher in a leader capable of tackling growing insecurity and deepening poverty in Africa's most populous nation.

The main opposition Peoples Democratic Party (PDP) and Labour Party say delays in voting in the February 25 presidential ballot and problems in uploading results through the BVAS need to be investigated and are challenging the results of the election. A court earlier had rejected an opposition demand to halt the reconfiguring of BVAS

so their teams could check for forensic evidence of ballot rigging. The Independent National Electoral Commission (INEC) said in a statement the court process had delayed its preparations for the vote for state governors.

"While the ruling of the tribunal makes it possible for the commission to commence the preparation of the BVAS for the governorship and state assembly elections, it has come far too late for the reconfiguration," INEC said. "We thank Nigerians and friends of Nigeria for their understanding as we continue to deal with these difficult issues." Election delays are not unheard of in Nigeria. In 2019, INEC delayed the presidential election by one week just hours before polling stations opened citing logistical problems.

INEC said the new governorship vote would take place, March 18. Ruling All Progressives Congress (APC) candidate Bola Tinubu, a former Lagos governor, won 8.8 million votes in the race to succeed Buhari, with PDP's Atiku Abubakar at 6.9 million and surprise third chal-

lenger Labour Party's Peter Obi at 6.1 million. In a bid to improve transparency, INEC introduced BVAS for the first time at the national level as well as its IReV, an online database for uploading results from local polling stations. But some voters and opposition parties said huge delays in voting and failures in the system when uploading tallies allowed for ballot manipulation and disparities from what was counted locally.

Legal ruling was the first volley in what is expected to be a long legal battle over the results of the presidential election. In 2019, when PDP's Abubakar lost to Buhari, he also challenged the results claiming irregularities. The supreme court dismissed his case months later. Obi, a former governor, filed to stop INEC from reconfiguring BVAS machines to give his team a chance to inspect them.

The court ruled that the opposition demand could not be granted because INEC needed to carry out the reconfiguration to hold state governor elections. The court said any

data could be safely stored on a backend server. INEC also said it reassured political parties and candidates that all data from the presidential election would be backed up and available. Obi, who won over many younger voters with his message that he would usher in change, had been in the Abuja court for the ruling. The Labour Party candidate said last week he would challenge the outcome of the election in court, claiming he would prove to Nigerians he had won the presidential race.

With the third largest number of votes, he managed a significant feat for an outsider in a country where two establishment parties, the APC and PDP, have dominated since the end of military rule in 1999. PDP candidate Abubakar, who lost his sixth bid for the presidency, denounced Tinubu's victory, describing it as "rape of democracy". International observers, including from the European Union, also noted logistical problems, disenfranchised voters and a lack of transparency by the INEC.

## UN urges ‘immediate’ end to Israeli-Palestinian violence

UNITED NATIONS (AFP): The United Nations urged Israel and the Palestinians to "immediately" end violence as intra-Palestinian tensions erupted following a deadly Israeli military raid in the occupied West Bank. Palestinian Authority security forces in the West Bank city of Nablus fired tear gas at mourners attending the funeral of a Hamas militant killed in raid, amid a surge in violence in the Israeli-Palestinian conflict.

"We are in the midst of a cycle of violence that must be stopped immediately," UN Middle East peace envoy Tor Wennesland said in a statement. "The Security Council has spoken with one voice, calling on the parties to observe calm and restraint, and to refrain from provocative actions, incitement and inflammatory rhetoric." Abdel Fatah Hussein Khroushah, 49, and five other Palestinians were killed during intense fighting with Israeli forces in Jenin, a scene of frequent clashes in the northern West Bank.

The Israeli army said Khroushah was a "terrorist operative" suspected of

killing two Israeli settlers in the Palestinian town of Huwara on February 26. An AFP correspondent at the funeral in Nablus saw Palestinian mourners hurling insults at police and equating the Palestinian Authority (PA) to "prostitutes" and "spies" for its coordination with Israel. In January, in the aftermath of another deadly Israeli raid in Jenin, the PA said it was ending security coordination with Israel. The PA is controlled by president Mahmud Abbas's Fatah movement, a rival faction to Hamas.

Palestinian security service spokesman Talal Dweikat said officers securing the funeral had intervened when an argument broke out after "a group unrelated to the martyr's family kidnapped the body and lowered it to the ground". Palestinian news agency Wafa reported, Hamas spokesman Abdul Latif al-Qanun condemned the PA officers' violence, arguing in a statement it "confirms the PA is part of the plan to repress the resistance" to the Israeli occupation. Qanun accused PA leadership of "going against the current and against the

will of our people" with what he dubbed "outrageous behaviour" by the officers. Businesses in Palestinian cities across the West Bank shuttered in a general strike to protest the deadly Israeli raid.

It was the latest in a string of fatal military operations in the Palestinian territory, which Israel has occupied since the Six-Day War of 1967. Thousands gathered in Jenin for the funerals of the five Palestinians killed alongside Khroushah, with heavily armed masked fighters firing volleys into the air, AFP journalists said. Near the blockaded Hamas-controlled Gaza Strip, the Israeli army said an "explosive device" was set off close to troops patrolling the border barrier, without causing any injuries. The army responded to the incident with fire. "Tanks struck a military post belonging to the Hamas terrorist organisation in the southern Gaza Strip," the army said in a statement.

Medics in Gaza said two Hamas members sustained minor injuries. Overnight, a rocket was fired by militants in the Palestinian enclave but appeared to be a misfire.

The army initially said it had fallen inside Gaza, but after searches on the ground reported it "fell adjacent to the security fence in Israeli territory" without causing any injuries. The violence in the West Bank and elsewhere comes amid celebrations for the Jewish holiday of Purim and against a backdrop of rising tensions since the beginning of the year, coinciding with the tenure of Benjamin Netanyahu's hard-right government that took office in Israel in December. Some observers fear further violence particularly around Jerusalem's holy sites during the holy Muslim month of Ramadan, which begins in late March, and the Jewish holiday of Passover in April.

Since the start of the year, the conflict has claimed the lives of 71 Palestinian adults and children, including militants and civilians. Thirteen Israeli adults and children, including members of the security forces and civilians, and one Ukrainian civilian have been killed over the same period, according to an AFP tally based on official sources from both sides.

# International Women’s Day and national apathy

THE world commemorated International Women's Day on March 8, and communities across the globe hailed women's contribution toward global development, social and moral progress of mankind and reaffirmed their commitments to women's empowerment, preservation of women's rights, and the greater role of the colleen in the modern world. The Pakistani nation observed this important day in a varied and utterly estranged way. During his message on International woman's day, Prime Minister Muhammad Shehbaz expressed his government's commitment to ensuring equal rights and opportunities for women in all fields of life. The Premier appealed for joint support by the government, civil society, and media in protecting women's rights in the country. Hours after the Prime Minister's commemoration, Police lashed out at women and transgenders gathering in the heart of the national capital during the Aurat March that was observed in connection with International Women's Day. On the same day, the Police charged batons and tear gas agaist PTI protestors during the Save the Judiciary rally in Lahore that cost a valuable human life and injured many during the violent clash. Meanwhile, the consultation session between the ECP and governor KP regarding the election ended indecisively, the Viceroy told the electoral body that suggesting the election date in Khyber Pakhtunkhwa was tremendously difficult because of the worst law and order situation in the province.

All that was about the prevailing utmost disagreement and chaos across the political spectrum, civil society, and government institutions, that every political faction and segment of the society is persistent to comprehend its objectives at all costs and is not ready to abide by the law and feel the sensitivity of the situation. In fact, the national constitution guarantees the civil rights of its citizens while the Chief Executive of the country upheld the state's responsibility but Police acted in a more regressive manner and played role in the creation of a catastrophe that might not happen if things moved in a normal manner. Similarly, the Supreme Court issued a piece of advice but governors, a few ministries, and state machinery were resisting the electoral process.

Historically, the role of public office-holders and politically influenced bureaucrats have undermined national interests and usually created a mess in national affairs due to their vested hidden interests. The majority of the leaders including the President, Provincial Governors, Speakers, and all present and past Ministers in the center and provinces blatantly violated their oaths and solely worked on political lines instead of fulfilling their constitutional obligations. Thus, the nation has witnessed the worst results of such selfish governance of the public representatives and government servants in the recent past.

Presently, the country has reached the brink of complete failure and no group has achieved its agenda through continued tussle and escalation. No single party was able to sail the nation through the prevailing crises. Apparently, national consensus and fresh elections are the only way forward at this point in time. Therefore, the coalition government must uphold the court verdict and move toward dialogue and the General Election, so a normal life could return to a crises-hit nation.

First went to Syria at the end of March 1982. Leaving aside the old city (whose beauty, centered on the great Umayyad Mosque, endures), Damascus was a grim place. Huge and menacing posters of Hafez Assad and his brother, Rifaat, adorned most buildings. There were beggars and child hawkers on the streets. The atmosphere was fearful: It was only weeks after the destruction of Hama, the ancient city on the Orontes, where the Syrian Muslim Brotherhood's Fighting Vanguard had made its last stand.

The Brotherhood - or at least those parts of it that favored a confrontation with the Baath Party - had imagined the time was ripe for a popular uprising against the Alawite-dominated and Hezbollah-supporting government in Damascus. They were savagely crushed by Rifaat's Defense Companies. Rifaat then saw an opportunity himself. While his brother was temporarily indisposed, he sought to launch a coup. It failed. He was exiled.

Meanwhile, an equally savage civil war was raging in Lebanon. And Israeli forces under the command of Ariel Sharon were seeking to destroy the Palestine Liberation Organization and - eventually - install a compliant Maronite-dominated government. The human toll was huge, not least in the Palestinian refugee camps of Sabra and Shatila. Elsewhere, the Iran-Iraq War was entering a phase of bloody stalemate, as Iranian forces retook Khorranshahr on the Shatt Al-Arab and pushed the Iraqi army out of the last meters of Iranian territory.

Forty years later, what has changed? Syria has been largely destroyed by a decade of brutal civil conflict. Hafez's second son is in charge this time. His opponents have been a motley crew of Islamists - the ideological and, in some cases, the actual

descendants of the Fighting Vanguard - along with old-fashioned Sunni ethnonationalists, some Druze and a lot of Kurds. There is no civil war in Lebanon. But the economy has collapsed, corruption has exploded (as have parts of Beirut port) and Hezbollah exercises an iron grip over domestic politics. Most importantly, Iran has constructed a network of allies and proxies from Iraq, through large parts of central Syria, all the way to the Mediterranean. It alone has benefited from the chaos. It is clear from the way it treats its own people that the Islamic Republic does not care about human suffering. It cares about its own survival, which it believes necessitates controlling or intimidating as many of its neighbors as possible. It illegally transfers ballistic missiles and other weapons to Tehran-aligned militias throughout this area - and indeed into Yemen - all designed to threaten not just Israel but anyone else who might stand in its way, including the states of the GCC.

It steals US dollars from the Central Bank of Iraq and through dedicated financial intermediaries and businesses across the region. With Hezbollah's support, it has enabled Syria to produce and smuggle enormous quantities of Captagon tablets, it smuggles gold and stolen cars, works hand in glove with South American narcotics gangs, and engages in human trafficking and fraud of all sorts across the globe. It kills young Iranian women and men who dare to protest. This situation is not the same as 1982. It is probably worse. But some things remain the same. If you want a unified Arab position against potential threats, you are going to need to factor Syria into the equation. Syria has borders with both Turkey and Israel and a de facto border with Iran. It also acts as the springboard for both Hezbollah and the Iran-aligned Iraqi Shiite militias such as Kata'ib Hezbollah and Asa'ib Ahl

Al-Haq. They established a position there with Iranian support after 2012 and have most recently been engaged in highly visible and self-interested relief operations after the disastrous earthquake that hit the northern regions of the country.

If Bashar Assad had been overthrown, the situation would still have been chaotic. But since he has survived, thanks to Russian and Iranian support, he is the man with whom anyone has to deal if they believe it important to take Syria seriously. He exploits this ruthlessly. This poses a set of dilemmas, both ethical and political. Assad bears a heavy responsibility for the calamities that have affected Syria over the last decade. He could have taken a different course after 2011 - as indeed he could have done during the so-called Damascus Spring of 2000/01. He could have loosened the repressive hold that the corrupt Baath Party had on the country without losing control. And he did not have to turn his goons loose upon ordinary Syrians - including children and women - who were simply protesting against brutality.

There were others involved, of course. The savagery of Daesh in its short-lived "statelet" around Raqqa and the Al-Qaeda affiliates in the northwest of Syria or Jaysh Al-Islam in parts of Damascus also contributed much to the disaster. As did the sheer fecklessness of the opposition in exile, the Syrian National Coalition, with its squabbling factions and the jockeying of its external backers as they sought to advantage the politically bankrupt Muslim Brotherhood and other clients. In August 2013, I was still the British ambassador in Riyadh and had a ringside seat. The failure of Western powers to take action after the regime's chemical weapons attack on Ghouta was, in my view, a turning point. It

confirmed Assad in his decision to double down. It also signaled to Moscow and Tehran that they could step into the vacuum without risk. They did so to great effect. Indeed, Russia went on to seize Crimea too. So, well done us.

And that is why there is now so much discussion within the GCC and in Egypt and Jordan about "bringing Syria back into the fold." Amman has been active along these lines for some time. Its foreign minister has visited Damascus. Jordan shares a long border with Syria and is quite reasonably concerned about the impact of the conflict on its own domestic security and stability. Egypt wants stability on its eastern flank to pursue its own project of economic rebuilding - an essential but uncertain enterprise. The speaker of its parliament was recently in Damascus and President Abdel Fattah El-Sisi phoned Assad after the earthquake to express his condolences. And the Arab states of the Gulf - some of whom have made public overtures to Damascus already, with visits by Bashar to the UAE and Oman and two visits this year by Sheikh Abdullah bin Zayed to Damascus - are worried that a bigger conflict with Iran may be coming down the track fast.

Under pressure from the International Atomic Energy Agency, the Iranians have accepted new inspections of their nuclear facilities. But the recent discovery of particles enriched to 84 percent - near weapons-grade - remains unexplained. The negotiations to relaunch the Joint Comprehensive Plan of Action nuclear deal ran into the sand months ago. Restrictions on Iran's ballistic missile exports expire this October. And the new government in Israel - in spite of its internal turmoil - has made it clear that Iran's enrichment activities are bringing conflict closer. The Israel

Defense Forces held joint all-domain military exercises with the US a few weeks ago. The signals are clear. So, you can hardly blame those who think that now is the time for hard-nosed pragmatism. Focusing on the chief threats to your own national security and setting lesser problems to the side has been the way of the world for centuries, whatever idealists may prefer to think. A government's first responsibility is to its own people. That was, in effect, the message of the Kingdom's foreign minister at the Munich Security Conference, where he said that the status quo on Syria was not working and a new one was needed.

But consider this too. Syria will need physical and economic reconstruction. Aleppo, Homs, parts of Damascus, the coastal strip, Idlib, Raqqa and Deir Ezzor, for example, have all suffered massive damage. Millions of Syrians are either internally displaced or are refugees in neighboring countries or farther afield. Many have had their properties seized and reallocated by the regime. What is to happen to them now? And who will pay for this? It will not be Iran or Russia, both with major economic problems of their own and whose response to the earthquake has been underwhelming.

Syria's own resources have been severely depleted. As a consequence, it has turned itself into perhaps the biggest narcotics state in the world. Its oil fields in the east are largely under the control of the US-backed Kurdish Syrian Democratic Forces, whose relationships with Turkey, Russia, Iran and Damascus are complicated and often murky.

Idlib in the northwest remains under the control of Tahrir Al-Sham, a one-time Al-Qaeda-affiliate that is trying to become respectable, with Turkish support. The Turks themselves have positions inside the border in Afrin and elsewhere and see the Kurds as their main enemy.

They will want to maintain freedom of maneuver while Recep Tayyip Erdogan calculates his own electoral advantage. The US, the EU and the UK are unlikely to ease sanctions in the short term.

None of this seems easily resolvable, either by Damascus or Iran. And anyone who decides that Assad is now the best of a choice of evils will have to bear in mind that he will demand a quid pro quo. That will come with a large invoice. And he has a record of non-delivery, so there is no guarantee that reengagement by his Arab neighbors will seriously affect his two-decades-long alignment with Iran. The balance of power that his father established with Tehran is now only a memory. Particularly after the exposure of Russian weakness in Ukraine, Bashar is now wholly dependent on Ali Khamenei for his survival. Relieving the suffering of ordinary Syrians is, of course, an act of mercy. But Assad will try to exploit any assistance to suit his own purposes, as he has done before. If the wider aim is to loosen Tehran's grip, then it will be a very long game indeed. And it cannot simply involve Syria. A long-term strategy will need to address the challenges of Lebanon and Iraq. As long as Hezbollah and the Iraqi Hashd militias call the shots there, Syria will not change.

Equally, serious political reform and the emergence of a strong anti-Hezbollah bloc in Lebanon, plus a start to the genuine economic integration of Iraq into the wider Arab Gulf community - perhaps initially through the creation of an integrated energy market involving Iraq's surplus gas - would be a good start. And then, who knows what will happen within Iran itself? You can reasonably argue that small and verifiable steps are perhaps the way ahead. But we should not expect things to get better anytime soon.

# Significance of ‘antisemitism’ diluted in race to defend Israel

AMERICAN leaders, from President Joe Biden and ambassador to the UN Linda Thomas-Greenfield to members of Congress, are speaking out against the rising tide of reported incidents of antisemitic rhetoric, especially on social media. Lawmakers in several American states, such as in Georgia just this week, have passed or are considering laws that define antisemitism, making it easier for prosecutors to target individuals engaged in anti-Jewish hate. However, they can also be used to silence legitimate criticism of the Israeli government's policies.

A good example is in Congress, where members like Illinois Rep. Brad Schneider are leading the charge, fueled by pro-Israel campaign donations. Schneider has defended Muslims, such as by co-

sponsoring a bill aimed at tackling Islamophobia, but he has also spoken out against criticism of Israel by pro-Palestinian groups and activists. Last month, Schneider introduced House Resolution 92, which declares that Israel is "America's legitimate and democratic ally," while condemning antisemitism, "including antisemitism masquerading as anti-Israel sentiment." Such moves might be legitimate in confronting genuine antisemitism, which is a hate-driven sickness, if in fact Schneider and many pro-Israel, anti-Palestinian groups did not include legitimate criticisms of Israel in their condemnations of antisemitism.

Schneider last month demanded, for example - in a congressional letter to UN Secretary-General Antonio Guterres that he co-signed along with 17 other members of Congress - the firing

of Francesca Albanese as the UN's special rapporteur on the situation of human rights in the Occupied Palestinian Territories. What did Albanese do to deserve this censure? She "repeatedly refused to condemn terrorist attacks against Israelis while continuing her condemnations of Israel." The letter accused Albanese of "strong bias against Israel" and stated that there is "deep-seated" antisemitism at the UN. The recent surge in denunciations of alleged antisemitism parallels the rise in pro-Israel political action committee money being donated to elected American officials. The pro-Israel lobby has funneled hundreds of millions of dollars into the campaign coffers of members of Congress, who then go on to suppress any voices that call out Israel's atrocities. Schneider, for example,

received \$19,460 from the American Israel Public Affairs Committee in the last campaign cycle, making it his fourth-largest donor.

His efforts to stamp out antisemitism might be genuine if only they spoke out as ferociously against the rising hatred espoused by Israeli leaders, such as Finance Minister Bezalel Smotrich. He recently urged Israel to "wipe out" the Palestinian town of Huwara after it was attacked by Jewish settlers. When word got out that the Biden administration was considering barring Smotrich from entering the US, where he is scheduled to address a rabid anti-Arab audience, he issued a clarification that his remarks were "an emotional slip of the tongue." But it was far from a simple slip of the tongue.

However, Rep.

Schneider and his colleagues did not release a statement or introduce a resolution denouncing Smotrich's hateful, racist rhetoric. Smotrich constantly defends Israeli violence against Palestinians, but Schneider is silent when Palestinians and their supporters are falsely accused of antisemitism because they denounce Israeli violence. By conflating legitimate criticism of Israel with anti-Jewish hate - and by tying it into a political blindness toward Israel's atrocities against non-Jewish Palestinian civilians - Schneider and his ilk are inadvertently diluting the significance of the term "antisemitism."

Antisemitism is about pernicious hatred directed against people who are of the Jewish religion. But it has been devalued and weaponized by people like Schneider as a means to defend Israel, while they

also remain silent in the face of true incidents of hatred against others. Many pro-Israel politicians in America show that they tolerate hatred by not addressing it when it is directed against Palestinians. They only vocalize their concerns when Israeli government policies evoke criticism of that country.

Hate is hate. Everyone should speak out against all hatred, regardless of the victim's nationality, religion or culture. Clearly, however, some of those who campaign to raise awareness of antisemitism have a sinister motive and aim to undermine efforts to stop hatred against Palestinians or anyone who criticizes Israel. Instead of curtailing antisemitism, the politicization of this term blurs its meaning and creates an environment in which actual antisemites can find cover for their hate.

# Race riots the latest evidence of Tunisia’s malaise

WITH a cult of personality taking shape, parliament's back broken and a neutered political opposition, Kais Saied's Tunisia is a world away from the one that gave birth to the Jasmine Revolution in 2011. Home to what had once been the only successful transition of power to democracy following the wave of regional protests, Tunisia's liberals have been enveloped by an authoritarian centralization of power, while the country's economy has been deemed "bankrupt," according to the most recent rating agency reports.

As national government debt has soared to four times gross domestic product, the otherwise-welcoming and peaceful country has been host to a stark increase in racist attacks and state-sanctioned arbitrary arrests of sub-Saharan migrants - a telling trait of a society that is broken.

Despite soaring youth

unemployment, a precarious fiscal situation and looming authoritarianism, Tunisian society has miraculously retained a certain calm. However, events in recent days - typified by the frenzied plight of Tunisia's sub-Saharan African community - show the extent of the malaise across all aspects of society. Saied last month denounced undocumented sub-Saharan African immigration to Tunisia in a meeting with the National Security Council. In comments that were later published online, the president declared that the arrivals were aimed at changing Tunisia's demographic makeup. He said: "The undeclared goal of the successive waves of illegal immigration is to consider Tunisia a purely African country that has no affiliation to the Arab and Islamic nations."

Playing on recent social media campaigns that have focused on the issue, the president has arranged for a makeshift prison to detain migrants, who now also

face heavy fines and public bullying despite already dealing with the travails of the legal limbo they occupy. In the wake of the record low voter turnout (the lowest since the 2011 revolution) at the December-January parliamentary elections, Saied has stoked xenophobic tensions to divert attention from the country's impending catastrophe and his government's inability to remedy it. Though the constitutional coup that brought him to power was seen by a large block of Tunisian society as a welcome opportunity to embolden the executive to reorder the country's political and economic life, Saied no longer enjoys widespread public support.

The president's efforts to rally the population around the issue of African migrants, whose presence has, in all fairness, increased the strain on the fragile Tunisian economy, have resulted in a situation

whereby sub-Saharan Africans are facing a surge of racist acts. He is not the first authoritarian to stoke up public fear and xenophobia to shore up his position amid rising food prices, unemployment and political instability. Black Tunisians, who make up about 10 percent of the country's population, have also been mistakenly targeted in racist attacks, bringing home the cost of irresponsible populism. Last week's attacks are only the latest controversy surrounding Saied, who seized power in 2021, dissolving the country's democratically elected parliament. Amid several other authoritarian actions, Saied has accused "traitors," who have been arrested as part of the latest crackdown, of "price fixing," "market manipulation," and "hoarding." Such fifth columnist rhetoric ties into a wider narrative that has characterized the president's escalating confrontation with critics who accuse

him of a coup and who the security forces have now arrested.

Tunisia last week banned a protest by the country's main opposition coalition, the National Salvation Front, but the group pressed ahead and on Sunday demonstrated against "political arrests and violations against public and individual freedoms." The protest came as the governor of Tunis, Kamel Feki, said such marches had "not been approved as some of its leaders are suspected of plotting against state security." Last month, the president's eccentricity in regards to counter-coups and plots against him reached a new low as he accused Esther Lynch, the Irish general secretary of the European Trade Union Confederation, of making statements that "interfered with Tunisian internal affairs" when she spoke during a protest organized by the Tunisian General Labour Union. Thereafter expelled from the country,

she was spirited out in scenes reminiscent of the darkest days of Zine El-Abidine Ben Ali's police state.

Within this context, the EU and US continue to "express concern." Their reticence and Tunisia's relative economic insignificance make the situation easy to ignore. The Saied government has long surrendered any semblance of democratic transition and its impending authoritarianism is drastically reducing the willingness of international partners to invest in Tunisia and, more importantly, provide the bailout the country needs. Tunisia's race riots are just the latest social disturbance caused by the country's increasing instability. To truly support the Tunisian people, international parties must condition future financial assistance on reforms and a term limit for Saied's tenure. Tunisia's powerful security apparatus should not expect foreign funding until they get behind a return to democratic rule.



# King Charles could help UK recalibrate its compass on EU

THE UK's King Charles III last week drew criticism from many on the right of the ruling Conservative Party for welcoming European Commission President Ursula von der Leyen at Windsor Castle. Her visit concluded a busy schedule in England, where she finalized with Prime Minister Rishi Sunak a new deal aimed at streamlining trade between Northern Ireland and the UK, dubbed the Windsor Agreement. This came after months of uncertainty, which had threatened to cause the collapse of the Good Friday Agreement, as the Northern Ireland protocol of the EU-UK Trade and Cooperation Agreement that governs the UK's exit from the bloc caused political and economic friction in the province and put at stake its future status within the union.

Though Buckingham Palace defended the meeting, saying that Charles was acting on "the government's advice," it was considered by some to be "constitutionally unwise" and it angered unionist parties, as well as the euroskeptical of the Conservative Party. Leading Conservative Brexiters Jacob Rees-Mogg said it was wrong to involve the king in the "immediate political controversy" on the day Sunak signed the new agreement with the EU. If the pic-

ture of the king warmly shaking hands with Von der Leyen at Windsor, where she was offered tea and discussed Ukraine, climate change and maybe Northern Ireland, caused controversy, I will not need to wait to see what kind of reception Charles' forthcoming trip to France and Germany (his first state visits since becoming king) will get back home.

The wiser branch of the Conservatives should, in my opinion, use the clout Charles has developed over the years to help heal tensions between the UK and EU. Only a close relationship with Brussels can turbocharge the UK's recovery from its Brexit-inspired slump, which has seen the country's growth performance dwindle to levels that have left its economic prospects for this year ranked second-last in the G20, only ahead of Russia.

The king and Camilla, the queen consort, will make a six-day trip to France and Germany at the end of this month. Charles will become the first UK monarch to give a speech from France's Senate chamber and to address Germany's Bundestag. The schedules for both visits, as described by Buckingham Palace, are aimed at celebrating Britain's relationship with France and Germany, "marking our shared histories, culture and values. It is

also a chance to look forwards and show the many ways our countries are working in partnership, whether that be to tackle climate change; respond to the conflict in Ukraine; seize trade and investment opportunities or share the best of our arts and culture." Charles' schedule will include meetings with both heads of states and, aside from the ceremonials, will include engagements that can only be frowned upon by parts of the anti-EU political class in the UK, especially if he chooses to address the members of parliament and senators in Paris in French. He will surely touch on everything that unifies and puts the UK at the heart of Europe despite Brexit.

He is due to meet with members of the British community in Bordeaux, where he will inaugurate a new British consulate building. In addition, he will tour areas south of the city that were ravaged by wildfires last summer, reminding everyone of the king's long-lasting campaigns to protect the environment. In Germany, Charles is set to meet refugees recently arrived from Ukraine and hear about the support the country provides for them, while the UK itself chooses to leave it to the hospitality of its own citizens to welcome only pre-approved refugees. The UK of the past few years, led by

the Conservatives' hard-line, anti-European government, has made bashing the EU a national sport, despite the self-harm inflicted on the nation's finances and the obstacles caused by Brexit for the manufacturing, farming, fishing and financial services industries. These sectors have, for decades, served clients across the EU, helping the growth and prosperity of the UK and keeping the country in the list of the top five or six largest economies in the world.

It is not a secret in the UK that the head of state, who traditionally remains politically neutral, is a europhile who is likely to always be at odds with the advocates of "taking back control" and "Singapore-on-Thames." It is customary for the king to only meet world leaders, whether at home or abroad, if the government advises him to do so. One wishes that this government could try to recalibrate its compass and see the benefits of ensuring a smoother relationship with the countries of the bloc next door. The royal household could help in this endeavor as, for centuries, Britain has been global, European and Atlanticist. But with Brexit and the rise of the desire to close its borders to immigration and allow anti-European sentiments to flourish, the UK is risking it all and losing its way as a leading European and global force.



## Western media hype ‘China woes’

MUCH has been said of the slow-down in the global economy and for sure, there have been reductions by the US, European, UK and even the Australian markets as they collectively fight massive inflation, stave off recessions and experience interest rate hikes that haven't been seen in a generation. Europe has spent a winter embroiled in a war, not just for territory in Ukraine but for limited supplies of natural gas.

While China has just set a target for around 5 percent of high-quality growth, those indicators of how bad it is globally do resonate here: there's no doubt global inflation and increasing interest rates combine to cause concern for China's economy, but the real truth is not what Western media want us to believe. Despite all those global problems, "China woes" continue to dominate financial media headlines. Contrary to the expectations of Western analysts, China has set bold targets based on incredible resilience and growth. Western media, however, love to give bad news.

Investment Monitor was headlined with a question: "Why are foreign companies decreasing their dependence on Asian Giant?" And then goes on to quote statistics provided by GlobalData which admits the data for 2022 is incomplete and mysteriously shows a graph of only four years, three of which were pandemic years. According to Trading Economics, which doesn't ask analysts for opinions but sources information from China's Ministry of Commerce, the real situation with Foreign Direct Investment into China was that it grew to a record \$189.13 billion in 2022 and in January 2023 set a monthly record of \$19.02 billion.

Business Standard

begins an article: "China's exports fell further in December as global demand continued to drop off." December definitely experienced a slump in productivity as COVID-19 restrictions were eased and, for a while, it seemed that many got sick. Dismal figures were to be expected, drivers, factory and port workers were on sick leave, and shops and some restaurants even temporarily closed.

If Western media are to be believed, the downturn in economy was so swift and so brutal that factories were closing two weeks early for the New Year holidays. But that was in January. The real truth was that some did indeed close early but many people in the West just didn't realize that this was an early New Year and, despite warnings from shippers, failed to prepare for a two-week closure just after their own Christmas holiday. The real statistics show China finished 2022 with export growth over 7 percent, a record \$3.6 trillion, and a record surplus of \$78 billion for December. There was a full year trade surplus of \$878 billion which was another record. China had exceeded all expectations.

The Nikkei Asia reported similar rhetoric that Hong Kong is struggling with the biggest plunge in exports in 70 years and this may be true but, again, blames the "early arrival of Lunar New Year" as if people didn't know it was coming. In an unusual abundance of balance, it also mentions that this isn't an issue with China, it's an issue of "slower global growth" and goes on to state there is weak global demand due to high interest rates and downturn in the tech cycle. It doesn't mention that China is one of the few countries in the world with an economy so strong that it reduced interest rates

nor does it mention the real reason.

The amount of shipping through ports such as Nansha, which is in the Greater Bay Area, has grown. This is of great benefit to Hong Kong as highlighted by Chief Executive John Lee in a December press release. In other words, while Hong Kong shipping is down, its overall business isn't, while imports and exports in Hong Kong may be lower than Nikkei would like us to believe in their headline, they are balanced enough to mention that the overall economy has grown 3.5 percent and is expected to top this year at 5.5 percent. This is partly because many Hong Kong businesses are relocating to Nansha and Qianhai, both of which are at the forefront of the Greater Bay Area which China incentivises to attract international investors.

To learn what's happening in China, we need to stop listening to "experts" and media analysts, instead, take a look at what China's Ministry of Commerce has to say: China achieved a 7.7-percent rise in foreign trade in 2022 and exports rose 10.5 percent. Foreign trade by private firms in China rose by 12.9 percent and, for the first time, exceeded 50 percent of the total while China has led the world in global trade for 14 consecutive years, including the three years of pandemic. Inside of China, fixed asset investment was up, industrial output rose and online trading increased to record levels. China kept inflation at just 2.06 percent and China's interest rates didn't go up in 2022 but went down, twice, catching CNN's "experts" completely by surprise. We don't need to be economists to know that these indicators aren't leading to collapse. Western experts seem to comprise of wishful thinking designed to manipulate, rather than inform.

## After the terrifying earthquakes, it's women and girls in Turkey feeling the aftershocks

IN Turkey's southern province of Hatay, one of the most ravaged cities in the recent earthquakes, 25-year-old Alev Altun, the mother of two young children, became homeless in one night, like thousands of others. Having nowhere to go, she agreed to take refuge in the house of her ex-husband, on his invitation, assuming it would be safer to stay with the father of her children than alone in a tent or in a building at risk of collapse.

While she was sleeping, her ex-husband allegedly poured scalding water all over her, shouting she should be grateful that he had not killed her. She remains in intensive care at a local hospital, with severe burns to her head, face and body. Hers is one of the many harrowing stories of women and girls in crisis zones. Women suffer disproportionately in the aftermath of disasters. While tens of thousands of people have lost homes and jobs, women continue to work ceaselessly in makeshift tents and containers set up for displaced survivors - finding food or trying to cook, washing or cleaning where water is available, constantly providing for others. In traditional, patriarchal societies, the entire burden of looking after extended families is on their shoulders. According to organisations on the ground, a large number of women were found dead - and occasionally pulled out alive - in children's rooms buried under piles of rubble. When the tremors began, they ran to save their children and babies. Unicef says the number of children who have died in the earthquake "is likely to be in the many thousands".

There are 356,000 pregnant women across the earthquake-affected areas. Of these, an estimated 39,000 are expected to

deliver babies in the coming weeks. For every affected woman and girl, but especially for pregnant women, the lack of toilets and cleaning facilities is a major source of distress. Growing up in Turkey, I have been told many times to be quiet about and ashamed of the female body, and especially menstruation. Still to this day, one of the widespread definitions of the word "dirty" (kirli) in Turkish dictionaries is "a woman who is menstruating". When I was younger, often when I bought a sanitary product from a market, I would watch the cashier immediately wrap it in some old newspaper, hiding it as if it was a scandal. Once, in Istanbul, I was scolded by a male grocer when I asked out loud in front of everyone where the period products were. He used a word I have never forgotten, ayip - shame.

In this sexist culture, female survivors of earthquakes find it very difficult to ask for sanitary pads. There is an assumption that within the broader picture of devastation and destruction, such matters are a trivial concern. They are not. Action Aid has said that the situation for women and girls and marginalised communities "is becoming increasingly alarming". In times of war and disaster, the rights and freedoms of women and minorities always become casualties to the "more important and urgent issues" of realpolitik. The humanitarian organisation Plan International has reported that, "Our experience shows that children, especially girls, women and the poorest families, are most at risk of exploitation in a disaster like an earthquake. Women and children in the disaster zone will be at risk of exploitation and abuse, should they find themselves once

again displaced." LGBTQ+ communities find the situation extremely hard. Sexual harassment and violence is a growing threat for many who remain vulnerable in homophobic and transphobic environments. There are reports from human rights organisations that it is harder to find a tent or access aid if you are a single woman. Hate speech is never far from the surface.

Wars, disasters and earthquakes also disrupt education. In Turkey and Syria, girls are much more likely to be pulled out of school. Turkey already has one of the highest rates of child marriage in Europe. Yet instead of helping women and minorities by implementing the Istanbul convention - the treaty designed to combat violence against women - the government under Recep Tayyip Erdo'an has done the opposite, withdrawing from the convention and targeting both feminists and LGBTQ+ activists. Erdo'an has repeatedly said that women cannot be equal to men and gender equality is "against nature". Crisis times bring out both the best and the worst in humanity. While we have seen a profoundly moving outpouring of help and support from civil society, there is a correlation between the lack of democracy, lack of accountability and high levels of corruption and nepotism in a country and the scale of suffering in natural disasters. Turkey's AKP under Erdo'an is not only antidemocratic and authoritarian, it is also blatantly macho and misogynist.

Sadly, anti-refugee rhetoric has also proliferated in Turkey after this crisis. In Mersin, Syrians staying at a dormitory were kicked out, saying they had to make way for Turkish citizens. Refugees have been put on buses and dumped on

the streets. Even those who were trying to help with rescue efforts have been assaulted in some places. In times of distress, instead of questioning the incapacity and structural mistakes of a government, it is easier to turn to the next vulnerable group and take it out on them. Meanwhile, on the other side of Turkey's border in Iran, girls are being poisoned. In at least 26 elementary and high schools, more than 1000 girls have reportedly been targeted in chemical gas attacks. Women and girls have been the leading voice in demanding social change, equality and freedom in the country. The bravery of Iranian women is remarkable: this is why they are being targeted by the regime.

We often hear that the world is presently suffering from multiple crises and therefore relief and aid efforts cannot be expected to continue for too long in one place. It is, however, possible to look at it from a different angle. Whether in Turkey, Syria, Afghanistan, Iran or war-torn Ukraine ... as we mark International Women's Day, women and girls and minorities across the world are suffering and struggling disproportionately. Gender-based relief efforts are essential to rebuild better and fairer societies. Studies show that when women are given financial aid and psychological support, they use this leverage primarily for their families, their children and their communities. There never has been a more urgent time for global solidarity, and especially, global sisterhood. There never has been a more urgent time to say out loud that we can both dearly love and care for our own countries or our adopted countries and at the same time be citizens of the world, citizens of humankind.

## Time for the US to show Israel some tough love by barring Bezalel Smotrich

SETTLERS on Monday wounded five Palestinians in a new attack on Hawara, only a week after their deadly rampage through the town. Israeli soldiers were even filmed dancing with the settlers as they together celebrated Purim, the Jewish holiday that commemorates the saving of the Jewish people from annihilation. This is the latest in a series of atrocities that have been conducted against Palestinians since the most right-wing government the country has ever known came to power at the end of last year.

Benjamin Netanyahu's government is becoming vocal in its persecution of Palestinians. There has been a lot of controversy around Bezalel Smotrich, the finance minister, who called for Hawara to be "wiped out." He is due to visit the US in the coming days. More and more voices are calling for him to be barred from entering the country. Though Smotrich tried to excuse himself by saying it was a slip of tongue, such slips usually reveal the real intentions of the person. Netanyahu is trying to keep the balance between pleasing his racist allies and appeasing the international community. However, the truth is so obvious, not only regarding the treatment of the Palestinians, but also when it comes to respecting any democratic norms. The government's judicial overhaul is a clear manipulation and distortion of the law to suit the interests of Netanyahu. Is that not what happens in autocratic countries? Isn't "democracy" the main reason why the US supports Israel? It is its supposed shared democratic values that

make Israel so special and so similar to the US.

However, Israel is showing that its democratic narrative does not match its daily reality, which is becoming increasingly racist. If we rewind, a major reason why the US has no credibility in the Arab and Islamic worlds is because of its biased attitude, its favoritism. Israel is treated on a different scale to everyone else. CNN's Christiane Amanpour, while interviewing Iranian Foreign Minister Hossein Amir-Abdollahian last week, tried to get from her guest an answer on what his own female family members think about the protests in Iran and whether they think women should have the freedom to wear the hijab or not. Amir-Abdollahian intelligently diverted the conversation by asking Amanpour if the US defended Shireen Abu Akleh, her fellow journalist, woman and Christian. He asked her if a UN resolution similar to the one issued against Iran was issued against Israel. Amanpour could not give him an answer. Why was Israel allowed to act with impunity? Why were Abu Akleh's killers not brought to justice?

No Israel advocate can defend the current government and say it is being democratic. No one can defend the demolition of homes or the pogroms like the one conducted in Hawara. If anything, the incident in Hawara reminds us of the antisemitic actions in Europe ahead of the Second World War. Israel has been able to act with impunity because it benefits from the muscle of the US in the UN Security Council.

Washington has consistently vetoed any resolution aimed at containing Israel's unbridled behavior. The only exception was during the presidency of Barack Obama. Toward the end of his second term, the US did not veto a resolution condemning the illegal settlements. He took this step as he was exiting the White House and knew that the pro-Israel lobby could not go after him. However, Israel is now becoming an embarrassment to its own supporters. The racist, Jewish supremacist ministers who are openly calling for Palestinians to be kicked out of their homes feel empowered. They know that, without them, Netanyahu would go to prison. They are no longer shy about showing their true colors. They are vocal about their real intentions. How can the US continue to justify its unconditional support for Israel? How can it veto any action in the UNSC?

The UAE last month decided against putting a draft resolution on Israel's settlement expansion plans to a vote. Instead, the UNSC issued a useless statement. We do not know what the inner workings were that led to this move, but it would have obviously been very embarrassing for the US to have to use its veto to defend Israel, especially as Russia is being criticized for using its veto power to block any resolution condemning its actions in Ukraine. Instead, the US has been going to the General Assembly to pass resolutions against Russia because Moscow can paralyze the Security Council. General Assembly resolutions are not legally binding, unlike those of the

UNSC. More and more, the US' use of its veto to defend the indefensible is looking like an abuse of power, very much similar to what Russia is doing to defend its invasion of Ukraine. Is the US getting a taste of its own medicine? It seems like it. No matter how you look at it, the US is getting squeezed into a tighter and tighter corner and its unconditional defense of Israel is becoming ever more difficult to justify.

Israel's far-right fanatics are experiencing what we call the arrogance of power. They do not feel they have to abide by anything except their blind racism and hatred of the Palestinians. However, the far right does not realize one important thing: The more it shows power, the more it is, in fact, losing power because it will be losing support. Losing the support of American Jewry is not an issue that the likes of Itamar Ben-Gvir and Smotrich should take lightly. The first step for the US to save its credibility - not only in front of the Arab and Islamic worlds but in front of its own audience, the American people - should be to deny the racist minister a visa to enter the country. The second step should be to stop using the veto to block any resolution condemning the illegal settlements. These steps would not only save America's reputation, they would also save Israel from a third intifada. The racist measures taken by the Netanyahu government will not allow Israel to get rid of Palestinians, but they will likely push the Palestinians to conduct a third intifada. Would Netanyahu want that? Would the US want that? Surely not. This is the time for the US to show Israel some tough love.

## Labour and SNP falling into Sunak's bear trap

KEIR Starmer's tactics at PMQs were quite simple - wrong-foot the Prime Minister by highlighting the shortcomings of the immigration system. Given recent events, this should have been an easy task. But somehow, Starmer spent the session flailing about - dispatching numerous heavy-handed jibes, yet rarely managing to land a blow. A total of 18,000 people were deemed ineligible for asylum last year, began the leader of the opposition. "How many of them have actually been returned?" he asked.

The PM dodged Starmer's question with the ease of a lawyer grounding a flight to Rwanda. Sir Keir, he said, was "on the side of the people-smugglers ... just another lefty lawyer standing in our way". The correct answer was 21 out of 18,000. "We all know the Honourable Gentleman's plan," crowed Sunak, buoyed by excited baying from the Tory ranks. "Open-door immigration and unlimited asylum!" Amid Tory jeers, Starmer hit back against the "lefty lawyer" slur by ... mentioning his stint as director of public prosecutions. The Speaker, in best geography master mode, tartly suggested to the noisier elements on the back benches

that continued rowdy behaviour would result in an early exit from the Chamber for "a cup of tea, probably a strong one".

Difficult as it is to imagine the Labour Party being tough on Channel migrants - like picturing Joan Collins in a tracksuit - Starmer was wise enough to focus his questioning on the Government's failure to restrict numbers of channel crossers, not the principle itself. Not so Stephen Flynn of the SNP, who asked Sunak whether his migrant policy was "taking inspiration from Nigel Farage or Enoch Powell?" Coming from the (white) SNP leader to a PM of Indian origin, this was bold enough. Given the non-existent numbers of migrants housed in Flynn's Aberdeen South constituency, it showed more of a brass neck than the Statue of Liberty. "What a load of nonsense," chuckled the PM, evidently delighted that Flynn had tramped so enthusiastically into the waiting bear trap. Everyone played to their respective galleries. Away from the Commons, crisp salesman turned BBC commentator Gary Lineker compared Tory immigration policies to 1930s Germany. Back in the Chamber Imran Hussain, of Bradford East, followed

Lineker's lead with an outburst of the "anyone who disagrees with me is Hitler" variety. The PM's plan, ranted Hussain, was "dystopian, far-Right, appeasing, anti-refugee ...". Once again, Mr Sunak suppressed a smirk. Operation "make the opposition look soft" was working.

"Graphic lessons on oral sex, how to choke your partner safely, and 72 genders," began Miriam Cates. No, this wasn't a question about the average male MP's internet search history, but about inappropriate sex education in schools. A few members of the old guard looked momentarily discomfited by this unexpected subject matter. Bill Cash glowered forbiddingly. Metaphorical monacles dropped all over the House. This being International Women's Day, a day of performative feminism and opportunistic marketing emails - "Happy #IWD ladies, have you tried this new lip filler?" - inevitably a few backbenchers hopped on the #girlboss bandwagon. Anna Firth used her parliamentary privilege to put the PM firmly on the spot with a tough question about women's football in Southend. Would the Prime Minister agree with her that sport, especially football, has the potential to empower women? Come back chauvinist grandees in top hats, all is forgiven!

He also observed that trade volume between the two countries stood at just US\$ 10,033.05 million in FY-2022. The trade included US\$1369.83 million in exports to UAE and US\$ 8663.22 million in imports into the country.

He said the existing trade volume did not match the actual potential of both countries and needed to be increased.

UAE ambassador agreed with the minister's point of view and said Pakistan and UAE have religious, durable, historical, and cooperative relations which needed to be enhanced with bilateral trade.

Telecom with 26,617,120 shares at Rs1.31 per share; Telecard Limited with 17,051,000 shares at Rs7.64 per share and Maple Leaf with 12,410,932 shares at Rs25.94 per share.

Atlas Honda Ltd witnessed a maximum increase of Rs19.59 per share price, closing at Rs280.79, whereas the runner-up was Thal Ind Corp with an Rs19.34.00 rise in its per share price to Rs288.90.

Pak Services witnessed a maximum decrease of Rs152.09 per share closing at Rs1,875.88; followed by Pak Tobacco with Rs43.57 decline to close at Rs675.10.

**Rupee sheds Rs3.17 against dollar:** The Pakistan rupee weakened by Rs3.17 against the dollar in the interbank trading on Thursday and closed at Rs282.29 against the previous day's closing of

Rs279.12.

According to the Forex Association of Pakistan (FAP), the buying and selling rates of dollars in the open market were recorded at Rs283.2 and Rs286 respectively.

The price of the Euro increased by Rs3.67 and closed at Rs297.86 against the last day's closing of Rs294.19, according to the State Bank of Pakistan.

The Japanese Yen increased by 04 paisa to close at Rs2.06, whereas an increase of Rs4.46 was witnessed in the exchange rate of the British Pound, which was traded at Rs334.43 as compared to its last day's closing of Rs329.97.

The exchange rates of the Emirates Dirham and Saudi Riyal decreased by 87 paisa and 84 paisa to close at Rs79.86 and Rs75.19 respectively.

A total of 8 ships were engaged at PQA berths during the last 24 hours, out of them a container ship MSC Asya left the Port on Wednesday morning, while three more ships EM Astoria, World Royal and Dolphin 03 are expected to sail later today.

ISLAMABAD (APP): Minister for Finance and Revenue Ishaq Dar on Thursday said that the staff-level agreement with the International Monetary Fund (IMF) would be signed in the next few days as all of the requirements had already been fulfilled.

"We are very close to signing the agreement with the IMF and it would be done in the next few days", he said while addressing a seminar "Reviving economic stability through strengthening of public financial management", organised by the ministry of finance here.

The minister said that the Pakistan Muslim League-Nawaz (PML-N) government had also completed the full programme with the Fund earlier in 2013-16 and was committed to completing it now as well despite agreeing to tough conditions by the previous government.

He said a shattered economy was handed over to the coalition government, however, it showed commitment and sincerity to the state by

acting upon all the tough conditions made by the previous government with the IMF.

Ishaq Dar regretted that petty politics was still being played over Pakistan's economy by spreading rumours about falling into default which he said was totally a nonsense attitude.

He said the bad economic crisis which the coalition government inherited was even more deeper and complex than that in 2013 and 1990s but with utmost sincerity and prudent policies of the government, the country had come out of the quagmire.

"We are now in a position to move forward with full confidence," he said, adding that Pakistan had the resilience to meet the challenges as it had huge resources to cope with the problems, but the only thing that had been lacking was lack of consistency in policies and mismanagement in the fiscal sector.

The minister informed that the country's debt-to-

GDP ratio improved from 73% to 69% in a few years which meant that there was no need to worry about the debts of the country.

He said even the developed countries such as USA and UK had high debt-to-GDP ratios of over 100%, therefore "we need not to worry about".

He said the country's foreign exchange reserves got down due to the fact that the government had been only paying back the debts and not getting new debts for the last few months.

Ishaq Dar also invited all political parties to sit together for resolving the country's long-standing economic issues by setting apart their differences.

Special Assistant to Prime Minister on Finance and Revenue Tariq Bajwa, pointing to the problem of the real estate sector, said that it had now become the most powerful group in the country. He said trillions of rupees were stuck up in the files of real estate which he called was a dead money.

He said the real sector must be reformed and taxed.

Secretary Finance Hamid Yaqoob Sheikh, in his presentation, showed measures to be taken by the government including reforms in power, pensions taxation and privatisation sectors to ensure sustainable growth of the country's economy.

Auditor General of Pakistan (AGP) Muhammad Ajmal Gondal suggested promoting industrialization to substitute the imports and reduce the trade gap. He said the government should also equally focus on increasing revenues without burdening the common man.

Deputy Governor, SBP Dr Innayat Hussain said the only solution to overcome the subsidies issue was to expedite the privatisation process. "We need to think why we have not been able to privatize even a single entity for the last several years," he said, adding that the privatisation structure and laws should be revisited to resolve this issue.

## Tokyo shares close higher

TOKYO (AFP/APP): Tokyo stocks closed higher for a fifth straight day on Thursday, with investors taking heart from recent rallies while awaiting a key US jobs report at the end of the week.

The benchmark Nikkei 225 index rose 0.63 percent, or 178.96 points, to end at 28,623.15, while the broader Topix index gained 0.97 percent, or 19.88 points, to 2,071.09.

"Caution about further acceleration of rate hikes spread against the backdrop of a tight US job market," IwaiCosmo Securities said.

"But the Tokyo market was buoyed following the strong performance of US high-tech stocks, especially

chip-related shares," the brokerage added.

Wall Street stocks were mixed overnight as markets weighed recession fears while a Federal Reserve report said inflation was persisting.

On Tuesday, Fed chair Jerome Powell triggered a sell-off by saying the "ultimate level of interest rates is likely to be higher than previously anticipated".

In his subsequent address to US lawmakers on Wednesday, he said officials would look at all the available data before making a decision.

Traders are now awaiting the release of crucial US non-farm payrolls figures Friday, which will provide the latest snapshot of the world's number one economy. Analysts said a

forecast-beating number could put pressure on the Fed to ramp up rates at its next meeting.

The dollar stood at 136.68 yen, against 137.43 yen in New York on Wednesday.

Shortly before the opening bell, revised government data showed Japan's economy did not grow in October-December, coming in at 0.0 percent, against a preliminary reading of a 0.2 percent expansion.

In Tokyo trading, industrial robot maker Fanuc gained 1.07 percent to 24,475 yen and Tokyo Electron, which makes tools to build semiconductors, jumped 1.24 percent to 48,640 yen.

Toyota added 0.62 percent to 1,919.5 yen while Honda grew 0.96 percent to 3,668 yen.

## Raducanu wrist injury returns before Indian Wells

INDIAN WELLS (Agencies): Emma Raducanu will "hopefully" be able to play at Indian Wells but says last year's wrist problem has returned. The 20-year-old British number one is due to play Danka Kovinic of Montenegro on Thursday in the 16,000-capacity Stadium 1. But Raducanu had strapping on both of her wrists during Wednesday's one-hour practice session with her coach Sebastian Sachs. "The same issue that I had last year has stared to flare back up," she said. Speaking to BBC Sport, she added: "I've definitely been managing my load. It's something that has just come back, so I'm trying to be as cautious as possible. "I'm going to do everything I can to be there tomorrow. "I think we always play through pain and it's just a matter of how much can you take - I'm looking forward to hopefully being out there tomorrow." The initial injury, which forced Raducanu to end last season early and miss the Billie Jean King Cup Finals in Glasgow, only affected her right wrist. There were not too many signs of discomfort in Wednesday's practice session, although she did take her hand off the racquet a couple of times. It was the first time Raducanu had practised since the weekend, and on Tuesday she pulled out of the Eisenhower Cup exhibition event in which she had been due to play mixed doubles with fellow Briton Cameron Norrie. Fresh concerns about her wrist follow a bout of tonsillitis, which cost Raducanu the chance to play in last week's ATX Open in Austin, Texas. "It affected me bad for the short term so I haven't prepared much. I've probably never felt so sick in my life," said Raducanu.

"When it rains, it pours. This and the infection - it's obviously a challenge. My preparation hasn't been ideal. I played on the weekend and then I rested it - it's how you manage things when you aren't prepared." Raducanu - the 2021 US Open champion - has been able to play just four matches so far this season.

# Fakhar, bowlers maul Islamabad in heaviest-ever PSL defeat

RAWALPINDI (Monitoring Desk): If Lahore Qalandars' thrashing of Islamabad United the first time these sides met this season read like an aberration, Qalandars gave them another one, just for good measure. In an imperious performance that consolidates their credentials as the favourites to retain this title, United were swept aside with disdain in Rawalpindi by 119 runs. It is the heaviest defeat inflicted on any side in PSL history.

Fakhar Zaman's 115 in

the first innings set them up for an imposing total - 226 is the Qalandars' second-highest score. But after Quetta Gladiators chased down an even bigger score the previous night, a chase felt very realistic. This is where Qalandars' bowlers shone, running riot through Islamabad's storied batting line-up and skittling them out for 107. In the end, Fakhar's individual score was higher than Islamabad's collected final tally, another PSL first.

After 240 hadn't proved

enough for Peshawar Zalmi the previous night, Lahore's decision to bat first was intrepid, but showed the faith they place in their bowlers, even on a surface like this. The start was wobbly, though, with Abdullah Shafique squeezed down leg in the first over. Crucially, Asif Ali dropped Fakhar Zaman when he was on one, and even as early as that in the game, it was a sliding doors moment.

After a tight couple of overs, Fakhar walloped

Fazalqah Farooqi for three boundaries, before plundering 16 in Faheem Ashraf's first over. Despite Kamran Ghulam struggling for rhythm at the other end, he only needed to keep turning the strike over, and Fakhar was happy to do the damage. By the end of the powerplay, Lahore were up to 65.

But they knew they needed a huge score against a batting line-up like United's, and they kept going. Fakhar took apart Shadab Khan in a seminal moment of the contest, while Ghulam came to life against Mubasir Khan. And Fakhar continued the onslaught against the United captain in a passage of play where 49 runs came off 14 balls, and the run rate ballooned.

United nailed the Qalandars down after Mohammad Wasim dismissed Ghulam, and briefly even threatened to keep the target around 200. But once Fakhar survived an extremely narrow lbw call - with HawkEye deeming a delivery crashing into the stumps to have pitched fractionally outside leg - he was rejuvenated once more.

Alongside Sam Billings, he smashed Wasim for 20 runs in the 16th over, and thereafter United's death bowling fell apart. He brought up the hundred in that over, and in a blizzard of boundaries Lahore helped themselves to 72 in the final five.

The notion almost seems quaint now, but on a Pindi surface that has helped batters out to the extent it has this week, the game wasn't over then. After seeing off Shaheen Afridi's first over respectfully, the United machine began to whirr, taking 27 runs off the two following overs.

It was Zaman Khan who broke the game open for the Qalandars with the wicket of Rahmanullah Gurbaz, who he'd tormented through the over, before finally putting him out of his misery with a short ball. A full delivery shaping away drew the curtain on Colin Munro's innings, and from thereon it was the Rashid Khan show.

Shadab Khan struck one six off him before the Afghan hit back, a top edge removing the United captain cheaply once more. The wickets were falling in clumps now: David Wiese soon got rid of Alex Hales

as he misused a slice right at the keeper. Islamabad United's own keeper, and middle order talisman Azam Khan, was unavailable following a finger injury he'd picked up in the first innings. In this kind of form, those are big shoes to fill, with the lower middle order hopelessly ill-equipped for the task against bowling of this quality.

That skill was crystallised in a glorious Rashid delivery to Mubasir Khan, drifting in around middle and whooshing past the outside edge to trim the outside of off stump. Faheem Ashraf was trapped dead in front, and by now an Islamabad mauling was inevitable. Rashid made it four wickets by cleaning up Asif Ali, and finishing with 4-21 on a surface every other batter had found to be a paradise.

Haris Rauf wrapped up the game with the final two wickets in a chastening evening at home for Islamabad to seal a top-two spot for his side. Both of these sides will go through to the playoffs, but on current evidence, the gap between them is a chasm.

# Our bowling was not up to mark: Babar Azam

ISLAMABAD (APP): Peshawar Zalmi Skipper Babar Azam feels not up to mark bowling cost them the game of the Pakistan Super League (PSL) 8 against Quetta Gladiators. Peshawar Zalmi and Quetta Gladiators added another classic to their epic rivalry on late Wednesday as the latter chased down a towering 241-run target with eight wickets in hand and 10 balls to spare at the Pindi Stadium.

In a match that saw 483 runs being scored – the highest run aggregate for an HBL Pakistan Super League match – records tumbled regularly. Some were broken in the run chase after only being made in the first innings. "You feel disappointed when you lose after scoring 200 runs. Jason Roy should be given the credit for his outstanding display. Our bowling was not up to the mark and we couldn't

The prolific batter said the wicket in Rawalpindi was also a batting one. "But the wicket here also supports the bowlers. The upcoming next two matches were very crucial for us. We will try to score 280 runs in the next match."

He said the team we played was the best. "You always go with the winning combination and this team has won us matches in the past. Salman Arshad performed very well for Zalmi last year but his performance was not the same in this edition. So we have to rest a player, so that he can sit back and regain his form."

To a question, he said it was his wish to score a century in PSL and he did but it would have been better if Islamabad had won. About Saim Ayub who scored (74 off 34), he said the way he's playing throughout the tournament it is outstanding and he was improving his batting with every

game. "He is improving day by day and I'm keeping an eye on all performing youngsters in the league. It is good for Pakistan that many players will come up. The more they will play they would get better."

Gladiators opener Jason Roy said it was his best innings in T20 cricket. "I was all the way till the end which is an incredible feeling as an opener. This innings will go on down to me as the greatest. This is my best T20 innings ever. It will definitely live long time in my memory. I'm feeling on top of the world."

On Babar Azam and Saim Ayub's innings he said, "That was incredible to watch; unfortunately, it was against us. I mean, it is the sort of stuff I watch on TV loads of times, with Babar the way he plays. I think that was his eighth hundred, and to watch it first-hand, it was extremely special, and he is a beautiful player to watch. And he was helped extremely well from the other end with his opening partner (Saim), the youngster coming through."

Pace bowler Hasan Mahmud, who forced Buttler to give a catch at long-on in the 16th over, finished with 2-26. Bangladesh got off to a positive start as Rony Talukdar (21) and Liton Das (12) put on 33 in the opening stand. Adil Rashid bowled Talukdar to break the stand and Jofra Archer soon removed Liton.

But Najmul and debutant Towhid Hridoy added 65 runs for the third wicket to put Bangladesh in control. Mark Wood bowled Najmul for some small revenge after conceding fours to the left-hander off each of his first four balls.

### IRSA releases 87,800 cusecs water

ISLAMABAD (APP): The Indus River System Authority (IRSA) on Thursday released 87,800 cusecs of water from various rim stations with an inflow of 56,500 cusecs. According to the data released by IRSA, the water level in River Indus at Tarbela Dam was 1440.87 feet and was 42.87 feet higher than its dead level of 1,398 feet. Water inflow in the dam was recorded as 23,300 cusecs while the outflow as 50,000 cusecs. The water level in River Jhelum at Mangla Dam was 1104.20 feet, which was 54.20 feet higher than its dead level of 1,050 feet. The inflow and outflow of water were recorded as 17,700 cusecs and 22,000 cusecs respectively. The release of water at Kalabagh, Taunsa, Guddu and Sukkur was recorded as 52,300, 40,500, 33,000 and 10,500 cusecs respectively. Similarly, from River Kabul, a total of 7,300 cusecs of water was released at Nowshera and 3,000 cusecs were released from River Chenab at Marala.

### Police arrest seven gamblers

RAWALPINDI (APP): The Rawalpindi district Police arrested seven gamblers and recovered Rs 25,600 stake money, seven mobile phones and valuables from their possession, said a police spokesman here on Thursday. He informed that R.A.Bazhar police conducted a raid and arrested seven gamblers namely Imran, Jameel, Shahid, Ali, Arslan, Imran and Jahangir who were allegedly involved in betting while playing table game. Case has been registered against the arrested accused while further investigation was underway. Superintendent of Police, Potohar Muhammad Waqas Khan said that gambling was the root cause of other evils and those involved in such crimes do not deserve any concession.

### Eight kite sellers arrested

## WAPDA to add 10,000 MW hydel electricity by 2030

ISLAMABAD (APP): Water and Power Development Authority (WAPDA) has embarked on an ambitious plan to double the share of low-cost, clean and green electricity to the installed capacity of the country by 2030.

Under the plan, an additional 10,000 megawatts (MW) would be added to the system during the said period, official sources told APP here. With the addition of over 10,000 MW, the generation would touch 20,000 MW from the existing 9,500 MW, they said.

The additional 10,000 MW would be added to the system through various ongoing mega projects like 4,500 MW Diamer Basha Dam, 4,200 MW Dasu Hydropower Project, 800 MW Mohmand Dam, 1,530 MW Tarbela 5th Extension and Kurram Tangi dam etc projects, they said.

They said that the capacity of Mangla Power House was also being enhanced through refurbishment and upon completion additional 300 MW would be available. The said mega projects would not only add a handsome chunk of hydel electricity to the system but also store another 12 million acre-feet (MAF) of water for agriculture purposes.

## ANF seizes 28 kg drugs

RAWALPINDI (APP): Anti-Narcotics Force (ANF) has seized 28 kg drugs and 9000 intoxicated tablets in three operations conducted in different areas and arrested an accused, said an ANF Headquarters spokesman here on Thursday.

He informed that in an operation near Peshawar Haji Camp Bus Stand, ANF recovered 24 kg charras and four kg opium from a parcel being sent to Lahore.

In another raid at International Mail Office Rawalpindi, ANF recovered 242 grams weed from a parcel booked for London.

He informed that in third operation at Karachi Pakistan International Container Terminal, ANF recovered 9000 intoxicated tablets from a container being sent to Dubai. ANF also arrested an accused resident of Karachi. Separate cases have been registered against the accused while further investigations are under process.

## Nine injured as van overturns in Shujabad

ISLAMABAD (APP): As many as nine people were critically wounded when a speeding passenger van overturned in Shujabad, a tehsil of Multan District in Punjab province on Thursday.

As per details, the accident occurred at the Motorway M5 in Shujabad where a van turned turtle due to overspeeding. Resultantly, nine persons, including women, sustained injuries, a private news channel reported.

Police and rescue teams reached the spot after getting information and shifting the injured to a nearby hospital.

# Pak-EU strengthening ties to deal with climate change: Ambassador

ISLAMABAD (APP): Ambassador of the EU to Pakistan, Dr Reena Kivinka here on Thursday said that the European Union (EU) and Pakistan were further strengthening ties to deal with challenges related to climate change, especially after the recent floods that wreaked havoc in the country, and to overcome barriers to gender equality.

Talking to a private news channel, she said the EU had expressed solidarity with the flood victims of Pakistan, saying the catastrophe was caused due to climate change. She also highlighted the steps being taken by the EU in mitigating the effects of climate change.

Observing that women were most vulnerable to such natural disasters, she said, "Around 85% of all

new EU programmes will have a special focus on bringing gender equality in Pakistan, as the overall women's participation in the decision-making process at home and community level is low."

She stressed the need to empower rural women to build their resilience to reverse the impacts of natural calamities in an effective manner. "Climate change is a global problem and needs global cooperation," she stressed.

"We believe that formulating answers to non-traditional security challenges such as climate change and promoting global cooperation is mandatory for achieving the Sustainable Development Goals (SDGs)", she added.

To another question, she

replied, "Climate change is our top list priority area and the joint commission was constituted for providing an opportunity to exchange views on all areas of cooperation between both countries."

Responding to a question, Dr Reena replied the EU with the collaboration of the Government of Pakistan had devised a policy for practical solutions to fulfill the needs of mothers and children in the flood-hit areas, including their educational needs.

Reiterating the EU's commitment in supporting women's rights and empowerment, she said, "Gender equality and the fight against violence against women was the core of EU policies in Europe and other partner countries."

## One more infected with Covide-19

RAWALPINDI (APP): One more person was diagnosed with fatal Coronavirus during the last 24 hours, raising the district's tally of confirmed cases to 47,773. As per the latest data released by the District Health Authority here Thursday, the infected cases included 44,126 from Rawalpindi and 3,647 from other districts.

The report added that the new case had arrived from the Rawal town area while five confirmed patients were quarantined at homes.

The report further updated that 7,006,011 people, including 44,790 health workers, had jabbed themselves against the lethal Coronavirus (COVID-19) across the district since the vaccination administering drive launched on March 10, 2021.

District Health Authority added that during the last 24 hours, 224 samples were collected, out of which 223 were declared negative, while the positivity rate was recorded at 0.45 per cent.

# NHA prioritizes road safety thorough maintenance programs

ISLAMABAD (APP): In a bid to prioritize road safety, the National Highway Authority (NHA) embraces maintenance programs to ensure safe, secure and comfortable traveling for commuters.

Talking to APP here on Thursday an official of NHA informed that the NHA launches safety schemes every year, which aim to improve highway safety standards and provide a comfortable experience for travelers.

He said that sewerage coverings were missing on the Hyderabad Karachi road which could lead to tire bursts and accidents. To avoid stealing sewerage coverings, the flaps have been welded and in addition to that, a demand has been sent to the Frontier Works Organization (FWO) for required coverings, he maintained.

The official said that the main component of maintenance work is highway safety and ensuring that the NHA puts up informative boards to

guide commuters and marks signs and warnings on the roads. He said that these signs and markings help drivers navigate the roads and avoid potential hazards.

In addition, he said that the NHA constructs pedestrian bridges to provide a safe crossing for pedestrians. He informed that the authority has recently constructed a pedestrian bridge in Lahore to provide a safe crossing over the busy Canal Road.

He said that one of the most important aspects of the maintenance program is routine maintenance, which covers a 10-kilometer stage and is awarded to contractors for the entire year. He said that contractors are responsible for maintaining the roads and keeping them free of potholes and patches along with repairing roads throughout the year.

For routine maintenance, the NHA also conducts periodic maintenance schemes for roads that have completed their lifespan or require addi-

tional maintenance beyond routine maintenance, the official said, adding that these sections cover an area of 15 to 20 kilometers and are part of the annual maintenance plan.

He said that once the scheme is approved, a contract is awarded and work begins. "The maintenance works include overlays such as functional overlay, structural overlay, and rehabilitation for roads that have reached the end of their lifespan", he added.

The official informed that in times of emergency, the NHA has special funds available in the budget for maintenance works and after approval from headquarters, such works are carried out in addition to routine maintenance work.

The NHA also awards contracts for tree plantation to promote a green environment and reduce the carbon footprint and the authority is committed to ensuring safety along with providing comfort to commuters through its maintenance programs.



### Six projects commenced

MAIDAN WARDAK (Agencies): 6 development projects with a cost of 4.8 million Afghanis with the support of the Afghanistan Social Livelihood Program were started in Maidan Wardak and Jalraiz District. The projects include road construction, cleaning of canals, and supply of drinkable water. These projects will be completed in 2 months, according to local officials work has been provided for 176 people.

# Blast in Mazar-e-Sharif kills 3 including Balkh Governor

MAZAR-E-SHARIF (Khaama Press): An explosion took place in northern Mazar-e-Sharif province on Thursday morning, claiming the lives of the provincial governor and his two security guards, according to local sources.

According to sources, a brutal attack took place in the premises of the provincial governor's office around 10 am on Thursday morning, as a result of which four people including Mohammad Dawood Muzammil, the governor of Balkh province were killed.

The province's Taliban police spokesman Mohammad Asif Waziri confirmed the death of the provincial governor and his



two security guards and said that two other people were wounded in the attack.

Waziri said that the terror attack took place during an administrative meeting, and the cause of the explo-

sion was not immediately known as no one or group has claimed the responsibility so far.

This comes as another explosion occurred in provincial district five in Kabul city earlier today,

with no further details about casualties and type of the explosion.

Despite the Islamic Emirate authorities have repeatedly claimed that the war is over in Afghanistan, security still remains a major challenge for the de facto regime. Islamic State Khorasan (IS-K) militant group has launched brutal attacks in the capital Kabul and other provinces, since the Taliban seized power in August 2021.

Over the past year, the militant group has targeted foreign embassies, a diplomatic mission, a Chinese-run hotel, and educational institutions in the heart of Kabul, which resulted in the death and injury of scores of innocent civilians.

## Jirga solidarity held among ethnic groups

PANJSHIR (Agencies): "Jirga of unity and solidarity among ethnic groups" was held in Panjshir.

During Jirga, Mawlawi Mohammad Mohseen Hashemi, Governor of Panjshir, said, "The Islamic Emirate is the protector of the interests of all the people, no one has the right to violate the rights of the people in any capacity, he said, the people of Panjshir are apart of the Islamic Emirate" adding that Panjshir people support the system.

Later, the head of the Jirga coordination of the Ministry of Border and Tribal Affairs, Mawlawi Abdul Khaliq Abid acknowledged the unity among people, said that the Islamic Emirate committed establishing unity in the country.

# OIC representative meets FM Muttaqi, discusses Afghanistan

Considering the existing situation, Afghan women's status remains under the international community's spotlight, with special attention on the violation of their rights to education and work.

## 30 schools to be restored

# Lack of female doctors in Paktika province



PAKTIKA (TOLONews): Paktika province has a population of 1.5 million people but just has three hospitals and two women doctors.

Officials in this province said that due to the lack of female doctors, they have to appoint male doctors.

Some residents of the province come to the hospital from far-off districts and called on officials to address their problems.

Gul Bi Bi is a resident of Jhoshmand district and after traveling six hours she came to the hospital and said

that due to the lack of hospitals, many women have suffered serious problems.

"There is no doctor, and we have to come very far to the hospital," said Gul Bibi.

"If the patient is coming from a distance, some times we lose our patients on the way," said Sarwar Khan, a Paktika resident.

Some female doctors at the central hospital said that due to numbers, they cannot care for all patients.

"Across Paktika we just have two specialist doctors that are in this hospital and

we are faced with challenges," said Eqra, a doctor.

"We have a lack of medical materials," said Mohammad Yahya Weyar, head of the central hospital.

"In Paktika province we just have two specialists, in the central hospital female doctors posts are empty and we are trying to hire male doctors," said Hekmatullah Hekmat, head of the Public Health Department. Paktika Central Hospital in the past month increased to 150 beds but still is faced with a lack of female doctors.

# ARCS called for OIC on children treatment with a whole heart

KABUL (Agencies): Head of the Afghan Red Crescent society, in a meeting with the special representative of the Organization of Islamic Cooperation for Afghanistan, asked for the cooperation of that organization in the treatment departments of mental patients

and children with atrial septal defect (ASD).

The head of ARCS, Mawlawi Mutiul Haq Khalis, met Tariq Ali Bakheet, the special representative of the Organization of Islamic Cooperation for Afghanistan, and Dr. Mohammad Saeed Al-Ayash, the repre-

sentative of the Organization of Islamic Cooperation in Afghanistan.

Khalis expressed his appreciation for the cooperation of that organization with the people of Afghanistan and called the OIC in the field of cash aid for the treatment of mental patients

and the treatment of children with perforated heart disease.

The special representative of the OIC assured cooperation in the mentioned sectors and promised to cooperate in the establishment of the artificial organs manufacturing center.

# Solution to Afghanistan's issues lies in regional cooperation: Iran



KABUL (Khaama Press): The ambassador of Iran in Kabul has stated that looking for a solution to Afghanistan's issues out-

side the region will not help the situation.

Hassan Kazemi Qomi, the ambassador of Iran to Afghanistan, tweeted last

night said the meeting was held in Tashkent, referring to an earlier gathering of special representatives from Afghanistan's neighbouring countries, demonstrating the significance of Afghanistan's political, security, and social developments for the region.

He said: "The Afghan caretaker administration's move towards forming an inclusive and reassuring government and protecting women's rights will be welcomed by the regional countries."

"The cooperation of the caretaker government with the region's countries and neighbours is the best way out of the bottlenecks," he added. The first meeting of special representatives on

Afghanistan's neighbouring countries was held on Tuesday in Tashkent, in which envoys from Iran, Uzbekistan, Pakistan, China, Russia, Turkmenistan, and Tajikistan participated in the meeting to discuss the current situation of Afghanistan.

The Envoys spoke about the current state of affairs in Afghanistan. They emphasized the need for long-lasting peace in the country and the provision of humanitarian aid to the Afghan people.

Since the international community does not recognize the current Afghan authority, the diplomats and Taliban representatives are not invited to important international conferences.

# Afghanistan severely divided by gender

KABUL (Khaama Press): The Special Representative for Afghanistan and the head of the United Nations said on Wednesday that the "Taliban claim to have united the country, but they have also severely divided it by gender."

Briefing the UN Security Council meeting, Roza Otunbayeva stated that at a moment when Afghanistan needs all of its human capital to recover from decades of war, half of the country's potential doctors, scientists, journalists, and politicians are shut in their homes, their dreams crushed their talents confiscated.

The 20th December prohibition on higher education and the 24th December restriction on women working for NGOs both have significant repercussions for the Afghan populace and the relationship between the Taliban and the international community, according to Otunbayeva.

She said that the reality is that Funding for Afghanistan is likely to drop if women were not allowed to work. Meanwhile, she added that "We understand that the Taliban have a highly different worldview than any other government, but it is

difficult to understand how any government worthy of the name can govern against the needs of half of its population."

The statement also stated that "women's rights, human rights, and girls' education" are the precise expectations of the Afghan people and that we will support them, Otunbayeva said.

Afghanistan remains the largest humanitarian crisis globally; two-thirds of the population, 28 million people, will need humanitarian assistance this year to survive.

This will cost \$4.62 billion, the single-largest

country appeal ever.

Almost half of the population, 20 million people, are experiencing crisis levels of food insecurity. Six million are one step away from famine-like conditions.

The humanitarian relief provided to the Afghan people is nevertheless disrupted by the bans on women working for NGOs because most of these organizations are run by women.

In the meantime, the envoy stated her worry that the de facto government would also ban the national women staff members who work for the UN.

# Fresh produce spoiling due to delays on Salang Highway: Traders



KABUL (TOLONews): Fruit and vegetable traders complained delays faced by transit vehicles on the Salang highway.

Traders said that in the last week more than a hundred truckloads of fruit and vegetables were spoiled due to stops on the road.

"We ask the government to make a separate lane for fruit and vegetable vehicles, so every time they can cross and not be stopped. Every trader has lost their property now," said Abdul Ghafoor Nasiry, head of the fruit and vegetable markets council.

"Some vehicles can cross without any problems, and I think that they allow some people to cross with money," said Tela Mohammad Ghafuri, a trader.

Meanwhile, the chamber

of agriculture and livestock called on the Islamic Emirate to allow fruit and vegetable transport vehicles to pass.

"We call on the government to allow fruit and vegetable cars and not to stop

them with stone and coal cars because the produce businessmen suffer a lot," said Merwis Naseeri, deputy of the Chamber of Agriculture and Livestock.

The Ministry of Public Works could not be reached

for comment.

According to the Chamber of Agriculture and Livestock, more than 200,000 people, directly and indirectly, are active in the fruit and vegetable sectors in Afghanistan.

## North Korea fires ballistic missile

SEOUL (Agencies): North Korea fired a short-range ballistic missile on Thursday, Seoul's military said, Pyongyang's latest show of force just days before South Korea and the United States kick off major joint military exercises.

Relations between the two Koreas are at one of their worst points in decades, with the nuclear-armed North conducting ever more provocative banned weapons tests as Seoul moved to ramp up security cooperation with Washington in response. Last year, Kim Jong Un's regime declared North Korea an "irreversible" nuclear power and vowed to exponentially increase weapons production, including tactical nuclear weapons, as the US looks to move more assets to the region to defend ally Seoul.

Seoul's Joint Chiefs of Staff said that it "detected the launch of one short-range ballistic missile from the North's western port city of Nampo at 6:20pm (0920 GMT)". It added it was analysing "the possibility that North Korea fired multiple short-range ballistic missiles from the same region simultaneously".

"Our military maintains a full readiness posture while closely cooperating with the US as we have strengthened surveillance and vigilance," it said. North Korea has long claimed its nuclear weapons and missile programmes are for self-defence, and has bristled over US-South Korea military exercises, describing them as rehearsals for an invasion. Earlier this week, North Korea accused the US of "intentionally" ramping up tensions, and Kim's powerful sister warned that if the US were to intercept one of Pyongyang's missile tests, it would be seen as a "clear declaration of war".

After talks between Kim and then-US president Donald Trump collapsed in 2019, diplomacy has stalled and the North has doubled down on military development. South Korea's hawkish President Yoon Suk Yeol has moved to boost diplomatic ties and security cooperation with Tokyo and Washington in response to growing threats from Pyongyang.

US President Joe Biden will host Yoon for a state visit on April 26, and the South Korean leader will also visit Tokyo next week, his office said. This month, the US and South Korean militaries will hold their largest joint drills in five years. Ahead of those exercises, named "Freedom Shield" and scheduled for at least 10 days starting March 13, the allies held air drills this week featuring a nuclear-capable US B-52 heavy bomber.

"This is likely only the beginning of a series of provocative tests by North Korea," said Leif-Eric Easley, a professor at Ewha University in Seoul. "Pyongyang is poised to respond aggressively to major US-South Korea defence exercises, as well as to President Yoon's upcoming summits with Japan's Prime Minister Fumio Kishida and US President Joe Biden," he said. "The Kim regime may order missile firings of longer ranges, attempt a spy satellite launch, demonstrate a solid-fuel engine, and perhaps even conduct a nuclear test."

North Korea has framed its missile tests and military drills as justified countermeasures following US-South Korea drills. Last week, it called on the United Nations to urge a halt to these exercises, and reiterated that its nuclear weapons ensured the balance of power in the region.

## Imran says he doesn't 'need' establishment

ISLAMABAD (Agencies): PTI Chairman Imran Khan said on Thursday that he doesn't "need the establishment", adding that he was willing to talk with everyone except "thieves". In an interview with BBC Urdu, the premier said that he only wanted elections to be held in the country as per the law and the Constitution, adding that he was willing to speak to anyone in this regard but did not need "crutches".

"I was asked if I would speak to the establishment if they wanted to talk. I said I'm a political person, I will talk to everyone except thieves," Imran said, an apparent reference to the coalition government. The publication reported the PTI chairman as saying that he never invited Chief of Army Staff General Asim Munir or Prime Minister Shehbaz Sharif to sit down for talks. "A statement has been circulating that I want to talk to the army chief [but] I don't need the establishment."

Imran further said that a political party that enjoyed the support of the people did not need "crutches". Asked whether the establishment's attitude towards him had changed after the change in the military com-

mand, the ex-premier told the publication that "it didn't make any difference to us." He said that cases against the PTI were made during the tenure of former army chief General (retired) Qamar Javed Bajwa. "Prior to this, such custodial torture was never inflicted on senior people."

"We had thought it would change when the new army chief would come but there has been no change and [our difficulties] have increased," he said. Imran's remarks comes days after PTI's Fawad Chaudhry clarified that the ex-premier had never made any request to meet with COAS Munir, terming "speculations in this regard as baseless". The statement was issued after senior journalist Kamran Khan tweeted about Gen Munir telling the country's business community that he had sent a message to Imran through President Dr Arif Alvi for meeting the prime minister which the PTI chairman did not agree to.

Kamran, however, claimed that Imran did desire a meeting with the army chief which the latter denied, saying he was not ready to interfere in the political process. It is pertinent to mention that earlier

this month, Imran said he was ready to talk to Gen Munir "for the betterment of the country", stressing he had "no quarrel with the establishment". In a wide-ranging discussion with reporters at his Zaman Park residence in Lahore, he had touched upon politics, his ties with the military, his frustration with ex-army chief Bajwa and why he chose not to fly to Islamabad for court hearings.

When asked why he was not speaking to the "establishment" — a euphemism for the military — he had said he never had a quarrel with the establishment, and it was Gen Bajwa that "stabbed me in the back". According to BBC Urdu, the PTI chief also touched on election and noted that the Supreme Court had ordered to hold polls in Khyber Pakhtunkhwa and Punjab within 90 days. He further said that the president had also made an announcement in this regard. But "the police comes when we take out an election rally," he said, in an apparent reference to yesterday's police crackdown on PTI workers in Lahore following the imposition of Section 144 in which a party worker was killed.

## Shehbaz, Magsi discuss political situation

LAHORE: Prime Minister Shehbaz Sharif Thursday held a meeting with member National Assembly Khalid Hussain Magsi.

During the meeting, they discussed the overall political situation in the country and other matters of mutual interest.

## PEMRA bans content on conduct of sitting judges

ISLAMABAD (INP): The Pakistan Electronic Media Regulatory Authority (PEMRA) on Thursday forbade the broadcasting and re-broadcasting of content pertaining to the conduct of sitting high court and Supreme Court judges on electronic media with immediate effect.

In the prohibition order, the regulator referred to previous directives wherein all licensees were directed to "refrain from telecasting any content against state institutions". PEMRA noted that despite repeated directives, satellite television channels were "persistently discussing the conduct of honorable judges of superior courts and orchestrating a vilification campaign through airing slanderous allegations".

The authority said airing any sort of content which prima facie referred to the conduct of judges or was against the superior judiciary was a sheer violation of the authority's laws and judgments of the apex court. Pemra also gave a reference to Article 68 of the Constitution in its order. The law states: "No discussion shall take place in [Majlis-e-Shoora (Parliament)] with respect to the conduct of any Judge of the Supreme Court or of a High Court in the discharge of his duties."

"Therefore, the competent authority i.e. chairman PEMRA, in exercise of delegated powers of the authority vested in Section 27(a) of the PEMRA Ordinance 2002 as amended by PEMRA (Amendment) Act 2007, prohibits broadcast/rebroadcast of any content pertaining to conduct of Honourable sitting judges of High Court and Supreme Court, in any manner, on electronic media (news bulletins, talks shows etc.), with immediate effect," the order said. The authority also directed all satellite TV channels to ensure that an effective Time Delay Mechanism is put in place and an "impartial editorial board" is constituted.

# Alvi for integrated approach to address mental health issues

ISLAMABAD: President Dr Arif Alvi on Thursday said that mental health illness was a major challenge and it required an integrated approach by all stakeholders, including relevant Ministries, Prime Minister's Secretariat, NGOs, psychiatric associations and civil society to cater to the mental health needs of the country.

He highlighted that 24 percent population of the country was suffering from some form of mental health issues that needed immediate attention of the government, health professionals, civil society organizations, and the media. The President expressed these views while chairing a follow-up meeting on mental health, at Aiwan-e-Sadr here. Head of Prime Minister's Strategic Reforms Unit, Salman Sufi and representatives of the Pakistan Psychiatric Society and Taskeen Health Initiative attended the meeting via video link. Country Director of WHO, Dr Palitha Mahipala, President of Pakistani-American Psychiatric Association of North America, Muhammad Zeeshan, Consultant at the National Commission for Human Rights, Ghulam Murtaza, representatives of Pakistan Psychological Association and senior officials of the government were present during the meeting.

The participants emphasized the need for a collaborative care model to provide services to the people suffering from mental health issues. Salman Sufi briefed the meeting about the initiatives taken by the Prime Minister's Secretariat to launch Humraaz, a platform to access mental health services and a Mental Health Helpline to assist people affected by mental health illnesses. He informed that 140 psychiatrists had been registered as yet to provide relevant mental health services and counselling to people suffering from mental health problems. He further informed that the Prime Minister would launch the Mobile App/Web portal and 1166 toll-free helpline on March 23, 2023.

Speaking on the occasion, the President underscored that all programs and initiatives with regard to mental health issues needed to be combined to help address mental issues in the country. Appreciating

the initiative taken by the Prime Minister of Pakistan on mental health and well-being, the President said that coordination with the Prime Minister's Office was very important, adding that all the work should be pooled at the Prime Minister's mental health program. He also lauded the efforts made by the NGOs and Taskeen Health Initiative that had done a tremendous job in this regard. Country Director of WHO praised the efforts made by the government and expressed his support for the initiative.

**President for giant leap in digital technology for improved economy, service delivery:** President Dr Arif Alvi also said for Pakistan, a big leap in digital technology was important to directly improve its economy and make progress in public service delivery. The president stressed that by leveraging digital technology, the country could explore advanced avenues of business in the revolutionized world.

Addressing here at a seminar on 'Digital System for public -Welfare, weaknesses and remedies', the president said Pakistan needed to make early decisions in technology and keep pace with the fast-changing world. President Alvi said the country needed a "full-throttle acceleration" on expanding digitalization in areas of public service delivery, including online banking.

Lauding the talent of the nation, he said the country was "standing on the gold mine of people". He said learning knowledge about FinTech (financial technology) and artificial intelligence could prove as a catalyst to progress. He said taking initiative in learning and getting the edge in technology was of foremost importance. In this regard, he emphasized working on intellectual ideas and early decisions on implementing digitalization strategy in diverse areas.

President Alvi, however, stressed that besides digitalization, the stakeholders needed to guide the consumers not to fall victim to online scams. He said scams could not be averted completely, however, their proportion to the delivery of services was important. He emphasized controlling online scams and frauds through continuous effort, including targeted messaging. He highlighted

how effectively the 130 million targeted cellular texts on early prevention of breast cancer successfully relayed a powerful message among the general public.

The president said the people had already adopted cell phone technology, and there was a need to guide them about the benefits of advanced technology. He said that older people were more susceptible to online fraud and needed to be educated about it. President Alvi recalled how the Covid-19 pandemic forced the nation to engage in e-learning and in various online projects.

Executive Director State Bank of Pakistan, Syed Sohail Javaid, presented a comparison of the modern banking system for the period 2012 to 2022. He informed that in 2012 only 1.4 million customers used digital banking, whereas in 2022, their number increased to 12.4 million. He said transactions worth almost Rs 11 trillion were conducted in the year 2022 and added that the number of transactions had increased from 12 million in 2012 to 141 million in 2022. He apprised that the number of ATMs had increased from 5,500 to 17,000, while the SBP had issued NOCs to five digital banks.

Banking Mohtasib of Pakistan, Muhammad Kamran Shehzad, said despite the advancements in technology and digitalization of the banking sector, people in rural areas were deprived of digital banking services, and were not aware of digital banking frauds. He stated that customers should not share their personal banking information on telephones to avoid becoming victims of online fraud. He informed that since the establishment of the Banking Mohtasib of Pakistan, relief worth Rs 5 billion had been provided to the complainants. Secretary General Pakistan Banks Association, Taufeq Hussain said that as a tool of financial inclusion, digital banking had become an integral part of the financial sector and was altogether different from traditional banking. He said digital banking played a critical role in the existing banking system, adding that it was convenient, efficient, speedy and cost-effective. The event was attended by representatives of commercial and digital banks, media, and the business community.

## Court issues non-bailable arrest warrant for Imran

QUETTA (Agencies): A local court in Quetta on Thursday issued a non-bailable arrest warrant for Pakistan Tehreek-e-Insaf (PTI) Chairman Imran Khan in the case registered against him under multiple sections of the Pakistan Penal Code (PPC) and the Prevention of Electronic Crimes Act, 2016 (PECA). The judicial magistrate issued the arrest warrant and directed authorities to present the former prime minister in court.

A first information report (FIR) was registered at a police station in Quetta against Khan for the comments he made against state institutions and their officers during a speech on Sunday.

Complainant Abdul Khalil Kakar had registered the complaint at the Bijli Road Police Station against the PTI chief. The FIR included Sections 153A, 124A, and 505 of the PPC and Section 20 of the PECA. Kakar had alleged that the PTI chief's statement was an attempt to destroy public peace and order.

In a speech on Sunday, the PTI chief had come down hard on the "state institutions" after a team of Islamabad police had arrived at his Zaman Park residence to arrest him in the Toshakhana case. The deposed prime minister — who was ousted from power in April last year — vented

his rage while addressing party workers and supporters at Zaman Park residence in Lahore who participated in the "Jail Bhao Tehreek" (voluntary arrest movement).

In his fiery speech, the PTI chairman said that he had neither kneeled before any institution or person nor would let the nation do so. Khan said it does not matter if the government places his name on the exit control list (ECL) as he has no intention of leaving the country. # Sindh cabinet decides to launch joint operation against dacoits

KARACHI: The provincial cabinet, after thorough discussion and deliberations, on Thursday decided to launch a joint, well-planned, and decisive operation cleanup against dacoits in katcha areas of the province in which the police of Punjab and Balochistan, Rangers, and Pak Army would participate.

The cabinet authorized the Inspector General of Police Ghulam Nabi Memon to coordinate with his counterparts of Balochistan and Punjab so that an operation could be planned in the katcha areas for which an amount of Rs2.79 billion was approved for the procurement of sophisticated Military-Grade Field and surveillance weapons.

The meeting was presided over by Sindh Chief Minister Syed Murad Ali Shah here at CM House on Thursday. Provincial ministers, advisors, special assistants, Chief Secretary Sohail Rajput, Chairman P&D Hassan Naqvi, PSCM Fayaz Jatui, and other concerned secretaries and offers

attended the meeting. Procurement of field weapons: The Home department and Inspector General of Police briefing the cabinet said that a joint operation in the katcha area of Sindh, Balochistan, and Punjab has been planned as per government decision for which procurement of sophisticated field weapons and surveillance equipment would be required.

The IGP said that the matter for the purchase of Military Grade Weapons and Surveillance Systems was discussed in the 28th Provincial Apex Committee meeting held under the chairmanship of Chief Minister Sindh on 5th January 2023. The meeting had approved the proposal. The IGP told the cabinet that the weapons and surveillance system was required to control hardened criminals/gangs, operating in the Katcha area of District Kashmir, Shikarpur, and Ghotki, equipped with sophisticated weapons.

The cabinet was told that funds amounting to Rs. 2,796.184 million were required for the procurement of sophisticated/military-grade weapons

to start a joint operation in which the police of three provinces, Sindh, Balochistan, and Punjab would launch the operation with the support of Rangers and Pak Army. The cabinet approved the proposal of the operation and also sanctioned the amount of Rs2.7 billion and directed the Home department to seek NOC from the Ministry of Interior for the purchase of the said weapons.

Upgradation of IT-related cadres: The Finance dept told the cabinet that the government has already upgraded 3871 IT-related posts and still 3,264 posts from grade BPS-5 to BS-16 were left over. The computer operators/lab attendants, Hardware, and other posts have been upgraded. The annual financial impact of the upgradation of the 3,264 IT-related posts on pay amounts to Rs.243.706/- million. The cabinet approved the upgradation.

Coronavirus fund closed: The provincial cabinet was told that the Coronavirus Emergency Fund was created on March 18, 2020, under the chief secretary with the secretary

finance, secretary health, Dr. Abdul Bari, Faisal Edhi, and Mushtaq Chhapra as its members. Right from the creation of the fund, 17 meetings were held.

During the period from March 18, 2020, to March 3, 2023, Rs. 3,312.93 million was donated from government entities, which includes Rs. 1,300 million transferred from the Sindh Social Relief Fund, Rs. 1,495 million, and Rs. 517.19 million donated through salaries deductions of Sindh govt Employees. Further, Rs.254.701 million was also donated from private entities and individuals. Foreign Donations received in CEF amount to Rs. 16.522 million including Rs. 16.268 million received through a Non-Profit Organization, M/s. I-Care Foundation, whereas Rs. 114.95 million was earned through profit on the saving account of CEF.

The CEF Committee has already recommended the closure of the Coronavirus Emergency Fund after clearing all financial and legal formalities. The cabinet decided to close the fund and the fund balance

amounting to Rs. 35,734,486 would be spent on the construction of houses for the flood-affected people. DHQ Dadu given to LUMHS: The provincial cabinet on the proposal of the health dept decided to hand over District Headquarters (DHQ) Dadu to Liaquat University of Medical & Health Sciences (LUMHS), Jamshoro along with administrative and financial control and SNE.

The cabinet directed the health department to ensure the provision of health facilities to the people of the area properly. The cabinet approved the release of funds amounting to Rs1.2 billion to the hospital so that it could start properly functioning.

In order to implement price control during the holy month of Ramadan, 2023, the Sindh Essential Commodities Price Control and Prevention of Profiteering and Hoarding Act, 2005 the cabinet approved the conferment of powers of Inspector Prices to Bureau of Supply & Prices officers throughout the province. The officers given powers to control price, include Director

General on the Sindh level, Additional Commissioner-I, and II (Divisional level), Director, BSP, (Provincial level), Deputy Directors, BSP, Sindh (Divisional level), Assistant Directors, BSP, Sindh (District level), Deputy Director /Additional Director Agriculture Extension. AFCs. DFCs Food Department, Assistant Director /DD Labour Department.

The district administration has already been given the powers and instructions to control the prices. The cabinet approved some appointments such as Minister Energy Intiaz Shaikh as Chairman Sindh Petroleum (Pvt) Ltd, a body part of the Energy dept, Minister Irrigation & Drainage Authority, Iqbal Detho as Chairman Sindh Human Rights Commission and granted an extension to Niaz Soomro, as Project Director Malir Expressway till the completion of the project. The cabinet also decided to appoint Aijaz Khanzada and Mohammad Arif Mithani as members of Drug Courts.
